The host country is Yemen, of which the Soqotra Archipelago is part.

Yemen is in active conflict and is not a secure location for either travel or hosting. While the Soqotra Archipelago is a secure location upon arrival, the routes used to travel to Soqotra are not secure (eg. flights through Yemen, boats from Salalah (Oman) across the Gulf of Aden). Flights from other locations are not commercial flights and can only be accessed through specific routes and contacts and for specific reasons. Hosting workshops at the Arab Regional Centre for World Heritage in Bahrain - a known and trusted partner - is an excellent option. Other locations could be considered, but would be logistically more complex and demanding to arrange, including difficulties in arranging entry visas for Yemeni citizens.

The Centre for Middle Eastern Plants (CMEP), part of the Royal Botanic Garden Edinburgh, has a long track record of working with partners across the Middle East in the fields of biodiversity conservation and sustainable use. This experience has been especially focused on the Soqotra Archipelago. Recent relevant projects include Darwin Initiative work in Afghanistan to reduce the unsustainable use of wild harvested plants for fuel, as well as local horticulture and market appraisal initiatives in Tajikistan to

reduce wild harvesting of wild plants with a view to increased livelihoods through local producer groups. RBGE has also run similar Darwin Projects in Tanzania, Nepal and Lao PDR as well as hosting a range of Darwin Fellows. It has also hosted Darwin Projects focusing on biodiversity conservation in Iraq and on Sogotra in the past.

CMEP is also currently managing projects on Soqotra that document the use of natural resources in traditional and cultural practices, as well as contributing towards the conservation of plant species through Protected Areas designation and management.

Q10. Justification of need for a Partnership Project

Please provide written details of why alternative funding is not available from within your own organisation or from other sources. Will matched funding be provided?

The cost of this partnership workshop involves meeting colleagues in a location outside the host country Yemen, due to security meaning travel to Soqotra is not currently feasible.

RBGE has very limited departmental core funds for travel, which would not cover travel and subsistence for one person for such a workshop, and certainly would not cover the costs of travellers from the host country to a third location.

By hosting the workshop at the Arab Regional Centre for World Heritage in Bahrain, there will be no cost for visas and no cost for hosting the workshop and this can be expressed as co-financing. Staff from RBGE will provide co-financing through in-kind staff time and overheads to undertake background research and time at the workshop, and to develop a full Darwin Initiative main project proposal.

EPA Soqotra has extremely limited funds and does not have any access to travel and subsistence funds for workshops.

The proposed partnership is therefore essential, to bring together local expertise, experience and implementation alongside global knowledge and expertise regarding sustainable use and benefit sharing. Although not named as an official partner, the International Institute for Environment and Development (IIED) have indicated that they are happy to provide advice and support to the proposed workshop through expertise in the biocultural heritage of indigenous people, and integrating livelihood benefits into SDG targets.

The Soqotra Archipelago, a World Heritage Site designated in 2008, hosts a range of unique biodiversity. Elements of this biodiversity are under threat - through unsustainable harvesting and use, through land management changes, and through development. For many years it has been discussed that the biodiversity, cultural heritage and livelihoods of the people of Soqotra is inextricably linked, but few

attempts have been made to ensure that the benefits of this biodiversity are shared equitably. There is great potential for a range of benefits, including financial benefits, to contribute to livelihoods and conservation on Soqotra, and for these benefits to be managed sustainably. There is no doubt, for example, that many plants and animals endemic to Soqotra can be purchased in many countries without any benefit to the people of Soqotra, and the same is true for plant-based resources and products which are harvested locally. No attempts have been made to quantify these markets or assess who the main beneficiaries are.

Under current conflict and uncertainty in Yemen, Soqotra does not have the ability to control access to resources and the equitable sharing of the benefits accrued. Since signing the Nagoya Protocol in 2011 there has been little opportunity to update regulations or legislation relating to Access and Benefit Sharing or to actively promote the benefits to local producers and communities.

This partnership will be established to bring together UK expertise to support Soqotra to enable benefits for the people of Soqotra, through examining the legal and regulatory mechanisms available to establish equitable sharing. It will go on to discuss a range of practical activities with local communities and NGOs to sustainably harvest plant-based resources and products, and the traditional knowledge that enables that process, to demonstrate how sustainable use and equitable sharing of benefits can contribute to livelihoods, poverty reduction, and biodiversity conservation through resource management.

Both UK and Soqotri partners will undertake basic research into contemporary harvesting and use, as well as past uses that could be restored and managed for increased benefits. Research will also be undertaken to identify current sales and markets that exist without contributing to Soqotri livelihoods in an attempt to highlight and prioritise activities for the future application. Identification of potential community and NGO groups that are active in relevant markets, or used to be, will be identified for further collaboration during the preparation of the full proposal.

Outcome: the unique biodiversity of Soqotra contributes to livelihoods in an equitable manner with measurable benefits for both people and biodiversity.

Outputs:

Published article documenting current uses and abuses of Soqotri biodiversity and the lack of transparency in access and benefit sharing;

Recommendations for new access and benefit sharing agreements and regulations;

On the ground activities that demonstrate livelihood and biodiversity benefits, that are sustainable and increase awareness of sustainable management through equitable sharing of benefits (including financial benefits);

Recognition and implementation of the role of women in traditional crafts that use biodiversity resources, and the equitable sharing of benefits among genders;

Soqotra is one of the poorest regions in a poor country currently suffering from conflict and instability. While there is no active conflict on Soqotra itself, it is isolated through reduced supply chains from Yemen and relies on alternative supply routes that can be extremely unpredictable. This places more pressure on local resources. The ability of Soqotra to make better use of it's natural resources, and to ensure the

benefits are shared equitably and benefit the people of Soqotra is therefore more important than ever. The project will focus on the Access & Benefit Sharing aspects of the Convention on Biological Diversity. It will also contribute directly to the assessment of where plant resources are located, how much can be harvested and yet still maintain healthy populations, and whether populations are conserved within Protected Areas designated as part of the Soqotra Conservation Zoning Plan. Several GSPC targets will be addressed directly. The outcome will contribute to several SDGs including No Poverty, Life on Land, and Gender Equality.

The project will identify a minimum of two interventions based upon discussions during the Partnership Project workshop. These could include, but not be limited to:

The establishment of nurseries that produce saleable seeds/plants that are either endemic to Soqotra or are hybrids derived from Soqotri material, for sale in international markets;

Production of plant-based resources derived from locally managed producer groups - examples could include frankincense (sourced from trees of the genus Boswellia) dragons blood (sourced from the Dragon Blood Tree Dracaena cinnabari), or aloes (there are currently five aloe species recognised as endemic to Sogotra).

The production and sale of items that use plant products in their production process - for example dyes and stains used in ceramics, carpets, and weaving - will also include the traditional knowledge associated with both harvesting and production methods.

Transparency and equity in financial management will be a key component.

The project partners on Soqotra will carry out all field activities, manage all local logistics and community and producer group and NGO works.

UK partners will meet Soqotri partners annually in Bahrain at ARC-WH. The named travellers would be the Lead Applicant and Project Managers for the resultant application, and those travelling from Soqotra would manage and coordinate implementation on the ground.

As Yemeni partners English is basic, translation costs are required for three days, based upon locally available translation services used routinely by ARC-WH at discounted rates (USD \$ per day).

Other costs

Yemen is not currently a secure destination, and Soqotra cannot currently be accessed through secure commercial travel. As such it is necessary to host the workshop in an alternative location.

The suitability of such a location is primarily determined through the availability of visas for Yemeni citizens. The Arab Regional Centre for World Heritage is one such location, and has hosted and supported similar workshops previously and also has an active programme on Soqotra.

The cost of bringing partners from Soqotra to Bahrain are included in the "other" costs, and include flights and subsistence. Flights from Soqotra only operate on Wednesdays, via Cairo to Bahrain, and to avoid the weekend this means that the workshop must take place Sunday-Tuesday and seven nights subsistence will be required.

Expected flight costs are USD \$ per person, with a subsistence rate including accommodation of approximately USD \$ per day.
