1. Outline progress over the last 6 months (April – Sept) against the agreed baseline timetable for the project (if your project has started less than 6 months ago, please report on the period since start up to end September).

The literature review started immediately once access to the University of York online library was received. From April to June two working days per week were spent on the lit review and thesis planning; the lit review and write-up will continue over the majority of the project lifetime. Methodology planning and testing took place in June and July with winter fieldwork occurring throughout August, approx. 3 days per week was spent on this where possible.

5 species that are planted within community forests are being studied: gumwood, black cabbage, scrubwood, ebony and she cabbage. 10 plots so far have been set up (see below) and aboveground biomass measured, soil samples taken and leaf litter collected:

- Gumwood: 1 plot at Millennium Forest, 2 plots at Peak Dale
- Scrubwood: 1 plot at Blue Point, 1 plot at Pipe Path Ridge, 1 plot at Ebony Plain
- Black Cabbage: 2 plots within the Peaks National Park
- She Cabbage: 1 plot at High Peak Ginger Patch, 1 plot at George Benjamin Arboretum

The remaining measurements required will be taken during the summer fieldwork, in addition to the ebony sampling. After consultation with island conservationists, permission has been given to destructively sample a small number of ebony plants, due to long-term plans for their removal from selected sites due to hybridisation concerns. Destructive sampling is not possible for any of the other species.

Finally, in late September I arrived at the University of York where I am auditing relevant modules, in particular Research Skills and Statistical Methods, and other modules useful to the project.

2a. Give details of any notable problems or unexpected developments that the project has encountered over the last 6 months. Explain what impact these could have on the project and whether the changes will affect the budget and timetable of project activities.

On the advice of my supervisors some specific equipment was ordered; the logistics of freighting items to the island meant that this delayed fieldwork slightly. However, this time was used to test out the planned methods using interchangeable methods. The delay will not have an impact on the project as these can be made up in the summer fieldwork period. Thus, this was not discussed with LTS International as it has no major impact on the project.

The number of species to be studied was reduced after consultation with supervisors, due to the amount of fieldwork which would be required, which would not be possible within the timeframe of this project. This will of course result in a smaller quantity of data produced by the project; however, the quality of the data will be enhanced. The species retained for study are planted throughout community forest sites, are well-known species on the island, and offer a broad range for an island carbon off-setting scheme.

On the advice of island conservationists, He Cabbage was dropped from the list of species to be studied due to the extreme rarity of the species. This was not discussed with LTS International as it was felt that this species has a similar growth form to the She Cabbage and thus there would be no negative impact to the project from dropping this species. Indeed, it is expected that the results for these species will be interchangeable.
