1. Outline progress over the last 6 months (April – Sept) against the agreed baseline timetable for the project (if your project has started less than 6 months ago, please report on the period since start up).

Activity 0.1 & 0.2: We held the Inception meeting and have negotiated and signed agreements with project partners. Steering groups have been established at the project sites.

Output 1: Field research is underway, with two field trips completed over the summer, to gather information about the numbers and location of herders and livestock, as well as the biological condition of the pasture. As part of a wider exploration of livelihoods in the communities, information on livestock raising has been collected through surveys, interviews and participatory discussion groups. Specific focal group discussions with livestock farmers are planned for Q3.

Output 2: It was decided to establish a woodlot of fast growing trees in one village in Year 1 and a second in Year 2 (to match budget availability). A suitable plot has been identified in Kyzyl Unkur and agreement reached with the local forest service to take responsibility for establishing and maintaining the plantation for the benefit of the community. The trees (*Salix nigra*) will be planted in autumn.

Output 3: A series of community and small group meetings have been conducted at the two project sites to jointly explore current livelihood strategies and opportunities. The scheme to support community-led initiatives was announced, and workshops held to explain how to complete the application and give training in developing a workplan and budget. Applications from community groups have been received, assessed and 40 initiatives selected for support (with Darwin and match funding). Initiatives include bee keeping, fruit growing, and a variety of other micro business enterprises such as bakery, hair dresser, poultry, and sewing shops.

Following identification and prioritisation of training topics at community meetings, training has been provided in community-based nature tourism; processing of fruits and berries; preparation, use and cultivation of (wild) herbs; and gardening.

Output 4: Training and resource needs assessments were conducted with the local forest service at Kara Alma and Kyzyl Unkur, with reports produced outlining the current situation and detailing the training and equipment identified by the forestry teams as necessary to effectively perform their duties. These plans have now been costed up, and training will be provided in forest legislation and computer skills in Q3.

Output 5: Climate adaptation measures appropriate for the project site were identified at a workshop with stakeholders. These will now be discussed with the communities.
