These websites are run by Defra. We want as many people as possible to be able to use these websites. For example, that means you should be able to:

- change colours, contrast levels and fonts
- zoom in without the text spilling off the screen
- navigate most of the website using just a keyboard
- navigate most of the website using speech recognition software
- listen to most of the website using a screen reader
- we've also made the website text as simple as possible to understand.

How accessible the websites are

- most of the website can be navigated with tab key and enter key in some cases where plugins or special features additional keys are required to select data and traverse maps
- the slideshow on the homepage can be paused using the keyboard and tab then enter to load a specific slide by hitting enter key on circles
- advanced search fields are keyboard accessible using tab and space bar to select the advanced search de-selection can be achieved with ctrl-shift-space combination.
- the project map, users should use tab button to get to the map then the arrow keys for marker navigation and tab enter for pop-up windows
- users are able to "skip to content" using the links located on the top of each page
- users are able up scroll to 200% and back down again without the overlapping on text
- the sites resize text based on window size
- the sites are mobile friendly and responsive for readers on mobile devices
