These included [1] updating the Darwin project website <u>www.harrison-institute.org/Darwin</u> [2] A total of 13 Darwin staff and trainees (2 UK and 11 Myanmar) participated in and presented three papers and four posters at two international conferences – 13th International Bat Research Conference, Poland, 23-27 August and the Trans-Karst 2004 International transdisciplinary conference on the development and conservation of karst regions, Vietnam, 13-18 September [3] Data contributed to Southeast Asian Mammals Databank (SAMD) at an international workshop in Thailand, 3-7 May [4] Three Darwin trainees (Yin Yin Toke, Nyo Nyo and Khin Mie Mie) successfully completed their PhD theses [5] One Myanmar staff member and one Darwin trainee undertook a study visit to the Harrison Institute, 16-23 August [6] One paper published; one paper (a bat species new to science) in press; five papers in prep [7] Darwin trainees conducted independent field studies in Myanmar [8] Further voucher specimens for the scientific collections of Yangon University and Harrison Institute [9] Further data analysed for the cave-bat and bat echolocation databases.
