## 1. Outline progress over the last 6 months (April – September) against the agreed baseline timetable for the project (if your project has started less than 6 months ago, please report on the period since start up).

- Butterfly farm infrastructure completed, planting of host plants completed and in process of establishment.

- Draft of the AC Management Plan completed and under revision.
- Sirua Foundation staff have received training in NGO management and GIS.
- Three weeks field training for rangers in biological monitoring techniques (taxa specific) completed.
- Biological monitoring system in development.
- Income generation projects (butterfly farming and cacao cultivation) established in two communities
- Strategic review of Sirua Foundation completed.

- First issue of the newsletter produced as an institutional triptych. Second issue is currently under development and planned to be released end of November 2005.

- Sirua Foundation web page under construction.

- A new person has been recruited (part time) by Sirua Foundation to support strategic and programme development, as well as to strengthen external relations.

- Final draft (awaiting completion of additional requested information) of bamboo feasibility study completed.

2. Give details of any notable problems or unexpected developments that the project has encountered over the last 6 months. Explain what impact these could have on the project and whether the changes will affect the budget and timetable of project activities.

- The North-western Ecuador area is passing a difficult moment because external actors (loggers, land traffickers and invaders) have been exerting more pressure on the forest and to the communities. They

have been making monetary offers to the communities in order to gain their support and to change their attitudes towards the engagement with various institutions, including Sirua Foundation. The pressures have been affecting our relationship with the communities, making it more difficult to hold meetings and to plan agendas and logistics with them. This does not mean that we do not have support from the communities, rather it means that we need to put more effort in maintaining our relationship with them. We plan on doing this by emphasising the benefits that the communities will receive from the livelihoods within the next year.

- The instability of the Government creates delays in all procedures requiring their input or approval and the rotation of public servants sometimes makes it difficult to maintain long term agreements.

- The Awa Federation changed Directors as part of their 3 year re-appointment. The new ones are very cautious of engagements with all institutions in general and they are revising all the agreements made by the old Board of Directors. As a result of this revision, all agreements have to be reviewed including the one with the Sirua Foundation. The Board of Directors had a preliminary meeting in which there was a positive response to the FS-Awa Federation agreement but the results of the final meeting will be communicated in December 2005.

To date this has not significantly affected the work plan or budget, however, should changes be seen we will contact the Darwin Secretariat.
