Our project started on 1 September 2004 and from that date is running to the original plan/timetable. During our first month we have begun to review the known Falkland invertebrates data, have planned the first field season and purchased/made arrangements to ship to the Islands the required equipment.

2. Give details of any notable problems or unexpected developments that the project has encountered over the last 6 months. Explain what impact these could have on the project and whether the changes will affect the budget and timetable of project activities.

As a result of the later than expected onset of this Project, the academic base in the UK has been moved from the University of Wales Bangor (UWB) to Cambridge University. The reason for this change is that the Project Officer (Dr A. Jones) is now affiliated with the University Museum of Zoology Cambridge (UMZC). Both UWB and UMZC are happy with this arrangement and have provided written statements confirming their positions (see attached correspondence). This change in situation will have no effect on the project budget or timetable, and will benefit the Project in that the taxonomic collections of the UMZC will be available for consultation and reference.

Have any of these issues been discussed with the Darwin Secretariat and if so, have changes been made to the original agreement?

The academic base change has been discussed with Carrie Haloun of the Darwin Secretariat who indicated that the new arrangement was satisfactory and acceptable.
