1. Outline progress over the last 6 months (April – September) against the agreed baseline timetable for the project (if your project has started less than 6 months ago, please report on the period since start up).

The project held the second training workshop from 14th -18th May 2007 entitled Invasion Risk Assessment in Tropical Ecosystems. This was originally listed as "alien species management" in the original Darwin application and was scheduled to take place in October 2007. The workshop taught 14 Tanzanian conservation biologists from 9 institutions up to date techniques in the risk assessment of invasive alien plant species. Five participants presented work that had been stimulated by the training workshop held in 2006, and carried out in the intervening year, or stimulated by the pre-preparation for workshop 2. All participants rated the workshop as "excellent" (from a choice of excellent, good, average, poor, very poor) and the majority felt that the knowledge gained from the workshop will be "very useful" in their work back at their institutions. One participant wrote "At first, I did not know where to start but now after the workshop, I do know how I can deal with alien species"

Eight participants have submitted joint research proposals based on the skills they learned on the workshop and are expected to complete the research by February 2008. These are new projects

that would not have been initiated if it were not for the workshop, and are additional outputs for the project over and above those originally planned.

Two Tanzanians attended a TBA tropical ecology field course. These were Jackline Herman Ngowi from the University of Dar es Salaam and Rehema Shoo from Sokoine University of Agriculture.

The two Darwin Masters students have completed their field work and are writing up. They both presented their research at the Invasion Risk Assessment workshop in May, and one has drafted a paper for publication. One of their supervisors attended the May workshop.

The PhD student has continued to make good progress and will return to Amani for his final field season at the end of the year. He made important contributions to the training workshop as a teacher but also learned new risk assessment techniques and principles.

The profile of the project has been raised through talks; for example TBA staff gave talks at Cambridge University, UK and at the Kibale Chimpanzee Project 20th Anniversary workshop held in Uganda.

2. Give details of any notable problems or unexpected developments that the project has encountered over the last 6 months. Explain what impact these could have on the project and whether the changes will affect the budget and timetable of project activities.

The project has not encountered notable problems over the last six months.

The project has not followed the original timetable and this was discussed with the Darwin secretariat in year 1. Some dates and activities have been changed in order to fit in closely with our partners' timetables which is partly an inevitable consequence of planning for activities that ultimately took place four years later. We are still on track to achieving the major objectives and outputs as presented in the original agreement, and main changes have been dates rather than the activities per se. It should be noted that all activities in this year are so far ahead of schedule rather than behind.
