The project started on July 1, 2005. PL (Mike Bruford) and PDRA (Benoit Goossens) travelled to Sabah in September. Several meetings were organised with the different host country partners: NGO HUTAN (Drs Marc Ancrenaz and Isabelle Lackman-Ancrenaz, Sabah Wildlife Department (SWD, Mr Laurentius Ambu)), Institute for Tropical Biology and Conservation (ITBC, Professor Maryati Mohamed)), and WWF-Malaysia (Dr John Payne).
