## 1. Outline progress over the last 6 months (April – September) against the agreed baseline timetable for the project.

The project is still running according to the original schedule and budget.

<u>Planned Project Implementation Timetable</u>: Financial Year Apr 2007-Mar 2008. Key Milestones: Q1&2: Exams; Continue research projects; Facilitate international university collaboration; Initiate Cambodian Journal of Natural History (CJNH).

## Actual Project Implementation Timetable:

**April:** The first cohort of MSc students continued their thesis research, conducting fieldwork and coordinating closely with other organisations in the natural resource sector. The second cohort of MSc students completed courses on Integrated Natural Resource Management and Environmental Impact Assessment. Two students studying aspects of bat ecology in collaboration with the Prince of Songkhla University in Hat Yai, Thailand, participated in a regional bat workshop in Phuket.

*May:* The second cohort of students completed a course on Environmental Impact Assessment, delivered by lecturers from the Department of Environmental Science at The Royal University of Phnom Penh. A website was created to help promote this Darwin Project within Cambodia and internationally.

**June:** Final examinations were held for the main courses of the first semester: Research Analysis and Natural Resource Management. Dr Lee Grismer, La Sierra University, conducted herpetological surveys in Phnom Samkos Wildlife Sanctuary with students and Darwin Scholars from the Darwin Project. Many specimens were deposited in the Museum and Dr. Grismer agreed to return in December to conduct the course on Ecological Survey Techniques.

**July:** The Bridging Course was reviewed by the FFI-RUPP Project Steering Committee and modified to reflect the new eligibility requirements for the Masters course. The new criteria require the candidates to hold any Science degree, not only in natural sciences, so the Bridging Course will include a new courses on 'Ecology & Evolution' and 'Biology & Genetics'. Re-sits were held for second cohort students who failed the key examinations in June.

**August:** Summer break for the Masters candidates. The Masters course was advertised in all the leading national newspapers and sent to all environmental NGOs and government agencies in Cambodia. 26 candidates applied from a wide range of backgrounds, e.g., protected area managers, GIS analysts and private sector managers to participate as the third cohort of

students.

**September:** The second semester of the Masters course began, with 12 students from the second intake who successfully passed their exams, together with two students who are repeating the semester from the year before. The Editorial Board of the Cambodian Journal of Natural History (CJNH) was created, with representatives from a range of British and other universities and organisations.
