1. Outline progress over the last 6 months (April – September) against the agreed baseline timetable for the project (if your project has started less than 6 months ago, please report on the period since start up).

Our main aims for this reporting period were as follows;

i. Produce the first project newsletter

One thousand copies of the project newsletter have been printed and are currently being distributed to project stakeholders. The project newsletter is a biannual event and therefore subsequent issues will follow every after six months.

ii. Conduct the Northern Serengeti and Minziro Surveys

The northern Serengeti and Minziro surveys were completed in July and September 2006 respectively. The Minziro survey revealed another new species of large mammal for Tanzania, the second new addition to the mammal list for our project. Results of these two surveys and the Tanga Coastal area survey which is to be initiated shortly will be presented in detail in our 2007/08 annual report next April.

iii. Print Mammal identification guide booklet

The mammal identification guide booklet that will be used during our interviews with local villagers living adjacent to protected areas has been finalized and several copies printed ready for use. The guide will be used by project personnel when interviewing local people to assess the presence of mammal species in their area, and copies will be made available to project collaborators and other data contributors to help improve the reliability of their sightings

iv. Initiate advanced training in website design and management and desktop publishing

The website development contract has two main components, namely website development and a tailor made course on website design and management for our staff. The first component began a month ago and will be followed by the training component once the web is up and running in the near future.

v. Advanced GIS and remote sensing training. This has been postponed until the first half of 2007 because that is the earliest that the course instructor is available.

vi. Development of a project website

The development of the Project website started this reporting period and it will be ready towards the middle of November 2006. When completed, the website will have the following address <u>www.tanzaniamammals.org</u>. All project staff have been provided with email addresses from the project domain (firstname@tanzaniamammals.org) to replace their old carnivore email addresses

vii. Develop Project Database

The set up for the Tanzania Mammal Atlas Project Database has been completed and can now accommodate a large variety of mammal species and their related habitat information. This process involved transforming the former Microsoft Access Carnivore database into a MySQL and PhP environment as well as adding an extensive list of mammals. Todate we have uploaded about 7600 mammal sightings into this new database from a variety of sources including the Carnivore project database, past camera trapping surveys and from reports and publications
