1. Outline progress over the last 6 months (April – September) against the agreed baseline timetable for the project (if your project has started less than 6 months ago, please report on the period since start up).

We have made good progress in this first 4 months of the project. Project MOUs have been drawn up, and are being discussed in advance of signing at the first project workshop early in 2007. The Darwin Fellow, Jorge Monterrosa, initiated the databasing of all fern specimens in LAGU (El Salvador) and has begun some field work ahead of time. He travelled to Chicago to examine and database the rich fern collections held in the Field Museum of Natural History from 1-15 October 2006. Almost 1000 (930 exactly) specimens of ferns collected in El Salvador were examined and databased, 150 of these were reidentified based on current knowledge. A poster entitled "Herramientas y entrenamiento para la conservación y monitoreo de helechos de El Salvador" was prepared by Monterrosa and S. Knapp of the NHM and was presented at the Congreso Latinoamericano de Botánica in Santo Domingo, Dominican Republic in late June 2006 by Knapp.
