1. Outline progress over the last 6 months (April – September) against the agreed baseline timetable for the project (if your project has started less than 6 months ago, please report on the period since start up).

This has been an extremely busy and productive period with a number of enhanced outputs in progress. Research outputs in particular are high. Collaboration with the molecular group in Nottingham has given strong molecular support for our recognition of a new family of land snails based on anatomical criteria and a paper describing the new family is in preparation. We have made presentations at a number of international and national meetings. Visits have been made to all partner countries in the past six months. SE Asian project partnerships are, as expected, achieving different but acceptable levels of activity. The new partnership in Malaysia is working particularly well.

2. Give details of any notable problems or unexpected developments that the project has encountered over the last 6 months. Explain what impact these could have on the project and whether the changes will affect the budget and timetable of project activities.

As set out in the Annual Report, we have taken control of the database at the NHM. Our Thai project partners have been slow in delivering the expected input of data for the database and a much larger than anticipated workload associated with the database will have to be carried out at the NHM in order to achieve associated target outputs. However, the Thai partnership is delivering higher than target outputs in research, media coverage, and the establishment of new partnerships in the Philippines and Korea. We have been concerned that full sets of accounts from Thailand were long overdue but accounts have now been supplied.
