Tuverea Tuamoto employed as a trainee at the outset of the project has progressed well, it was therefore decided to re-grade him as a conservation officer and give him split responsibilities with the seabird restoration programme to replace a member of staff who has emigrated after his partner's job was relocated. This has left a vacancy and a position advertised for a new Darwin Trainee and after interviews this was awarded on short term contract to Mere Valu – one of the two sponsored students. Her role is to implement the IBA monitoring methodologies with communities at project sites and to support other activities under the Darwin project.
