IUCN Red List to contain assessment of all Malagasy chameleon species

Following the workshop held in Q1 of 2011 the project team worked with people in the IUCN Species Survival Commission and Chameleon Specialist Group to conduct a quality check and consistency assessment for the reptile accounts. These were completed in August 2011 and the IUCN Red List update with the Malagasy chameleons is scheduled for 10 November 2011.

All chameleon species assessed for their potential as a harvested resource

The CITES Management Authority of Madagascar submitted its documents to the Animals Committee meeting after the deadline. The assessment of the detailed account of chameleons, prepared by the project team that included information of their potential for sustainable trade was postponed to the 26th Animals Committee meeting in March 2012. A member of the project team attended the 25th Animals Committee meeting in Geneva as part of the IUCN SSC's delegation. The project team returned to the Ankaratra Massif to collect field data on the biology of Furcifer campani – a strong candidate species for resumed international trade.

Enhanced host country capacity to conserve and sustainably manage endemic chameleon species

The project team maintained regular contact with the Malagasy CITES Authorities throughout the reporting period. This included two meetings in preparation for the 25th Animals Committee and a post-meeting feedback session. The Malagasy students on the project continued preparing their research theses, with three at the University of Antananarivo and two from the University of Toliara approaching their vivas. Jean Victor Nadege Rafanomezantsoa obtained his Licence Professionnelle degree on Biodiversité et Environnement at the Département des Sciences Biologiques of Toliara University on "Étude et suivi des populations de caméléons dans les villages de Sakabera et de Belalanda, Sud-Ouest de Madagascar. The project produced an identification booklet for the *Furcifer* chameleons of Madagascar and the Comores. A hundred copies were printed and these are now being evaluated by experts.

Assessment of the illegal trade in chameleons between Madagascar and South-East Asia The final report from this part of the project was published and attracted considerable publicity http://news.mongabay.com/2011/0619-hance malagasy thailand.html.
