1. Outline progress over the last 6 months (April – Sept) against the agreed baseline timetable for the project (if your project has started less than 6 months ago, please report on the period since start up to end September).

Project purpose is: Improved national and local capacity to reduce direct threats to leopard, lion, cheetah and wild dog by mitigating <u>C</u>onflict; ensuring sustainable <u>U</u>se; and reducing illegal <u>Trade CUT</u>).

## Progress on activities scheduled for Q1 and Q2:

- 1.3 Adapt Human-Wildlife Conflict (HWC) Toolkit for use in Tanzania
  - The HWC Toolkit has been discussed during conflict working group meetings and a team of species experts has been identified to review the FAO HWC Toolkit for species relevant to Tanzania. A workshop for compiling the review and adoption is scheduled for 24<sup>th</sup> November 2014.
  - The FAO Tanzania country Office has been officially contacted (via Tanzanian government channels) to explore funding for rolling-out of the HWC toolkit in Tanzania. FAO have expressed an interest in providing further support.
  - Additional funding has been secured from the St. Louis Zoo to train wildlife stakeholders in Tanzania on the use of the HWC toolkit
- 1.5 Conduct field trials of agreed standardised protocol at three pilot sites
  - 25 predator proof bomas have been constructed in five villages of Longido district with additional funding leveraged from the UNDP Country office in Tanzania.
  - Different models of predator aversion lights have been selected for testing in the field as a mechanism to protect temporary bomas.
- 2.2 Carry out pilot survey at 4 sites within hunting concessions, documenting manpower and financial resources used.
  - A spoor survey for estimating density of lion and leopard was completed in Maswa Game Reserve

- A plan for camera trap survey has been developed for the Selous Game Reserve in November 2014
- 2.3 Analyse data from sites and use to refine survey protocol
  - Camera trap survey data for leopard captures in the Maswa Game Reserves have been matched and are currently being analysed and written up.
- 3.2 Develop training curriculum, manual and interpretive materials for customs officers at exit points
  - CUT has been working closely with TRAFFIC and WD in developing materials for training of customs officers.
- 3.4. Established centralised database and reporting for all trafficked large carnivore products
  - A centralised database for reporting trafficked large carnivore products was set at the start of this project.
  - During the period under review, a total of 83 records have been entered into the database. Of these, only two were from carnivores
- 4.1 Provide training to establish an effective CUT carnivore threat coordinator and a minimum of 4 senior staff at TAWIRI trained as trainers in all aspects of the project.
  - Training is an integral part of the CUT project. During the period under review TAWIRI staff carried out a training needs assessment. Field teams were trained on spoor surveys for large carnivores and individual identification of leopards and managing the project database. The project coordinator will be attending a two week project management skills training course at ZSL in London at the end of October.
- 4.5 Provide training to customs officers at priority exit ports to enable better identification of large carnivore products, improve reporting and enforce CITES legislation
  - Plans for two training workshops have been finalized and training scheduled for the last week of November 2014 using additional funding secured from the Howard G Buffett Foundation. Training will involve an estimated 30 customs officers from each of two priority ports: Julius Nyerere International Airport and the Dar es Salaam harbour port.
- 4.6 Establish stakeholder network and issue quarterly email newsletter to deliver news, report project progress and raise awareness of CUT issues
  - A stakeholder network has been established. During the report period a total of 11 new members were added to the network that makes now 48 members
  - Third issues of the quarterly e-newsletter have been produced and circulated to stakeholders

It should be noted that at the end of year 2 our project was behind schedule, and our annual review requested an update. We have two major workshops planned for the end of November, at which point we will have delivered on 70% of our activities. The remaining 30% of our activities are dependent on our final objective – a CUT plan for large carnivore management. This will be delivered through a workshop process planned for February 2015.
