1. Outline progress over the last 6 months (April – September) against the agreed baseline timetable for the project (if your project has started less than 6 months ago, please report on the period since start up).

Project start date: 1 July 2012.

Project inception/ Research Planning Workshop: The inception workshop was held from the12th to the 14th of July 2012. The location was changed from Kabale to Kampala so that more national stakeholders were able to attend and involved introducing the project as well as making initial plans for the research and advocacy work. The project partners (IIED, JGI, ACODE and ITFC) reviewed the research activities and project outputs with national and local stakeholders. Roles and responsibilities were agreed between the project partners.

Inception workshop report: A workshop report was produced in consultation with the project partners and is available to download on the project website [http://bit.ly/XSKEvg].

Raising awareness about the project: In order to raise awareness, a press release was made to Ugandan journalists, introducing the Uganda Poverty and Conservation Learning Group, the purpose of the Darwin project and the workshop report http://www.iied.org/uganda-project-strengthen-policies-link-poverty-conservation, this was picked up by a few media outlets including "News from Africa"

Preparation for field surveys on resource use behaviour: ITFC held consultative meetings with local stakeholders including local leaders, all Community Conservation Rangers (CCRs) and the Law Enforcement Warden in Buhoma in August. This introduced the project and built rapport. ITFC has also conducted meetings with wardens and rangers (who will be collaborating on the project) at all ranger posts to explain the project's purpose.

Literature review: The research team is carrying out a literature review, focused on previous studies that have looked into different resource user groups around Bwindi Impenetrable National Park (BINP). In addition members of the wider project team are contributing a book chapter titled "Linking protected area conservation with poverty alleviation: an evaluation of ICD at Bwindi Impenetrable National Park, Uganda" for a book called "National Parks: Sustainable Development, Conservation Strategies and Environmental Impacts" due to be published by Nova Publishers.

Development of methods: The methods for the project are currently being designed by the

project team and Uganda partners and will shortly be reviewed by scientific advisors from Imperial and Cambridge.

Ranger Based Monitoring Data: Bwindi Rangers around BINP are sharing data about unauthorised resource user groups with the project's lead research partner ITFC. A monthly arrest form has been designed to document profiles of unauthorised resource users, which will help to understand trends in resource users around the park and where they are located. Meetings are being carried with rangers every month to discuss the challenges involved in filling the monthly arrest forms and gain insights helpful to the project.

No unexpected developments – the delayed start to the project was agreed with LTS via a formal change request in March 2012. .
