1. Outline progress over the last 6 months (April – Sept) against the agreed baseline timetable for the project (if your project has started less than 6 months ago, please report on the period since start up to end September).

The following progress has been achieved (April-September, 2015).

Outputs 1.1a and 1.1b:

Activity: Workshop (26-28 April, 2015), which took place at Mandalay, on the Ayeyarwady River, and Hsithe village.

Organised and led by: Aung Myo Chit of 'Grow Back for Posterity'.

Supported by: Darwin Initiative (financial support); Irrawaddy Princess River Cruises (support in kind – loan of boat); and the Department of Fisheries, the Myanmar Tourist Guide Association Mandalay Zone, Tour Guide Mandalay, and the local communities (logistic and participatory support).

Objective: Follow up to previous workshop of 9-11 December. 2014 (see Manual at http://media.wix.com/ugd/cec980 bcecdeddcbe64c15b4623cff7557b093.pdf) in order to reinforce training of tour guides, tour operators and boat owners for operating within the Irrawaddy Dolphin Protected Area (KBA 85) on the Ayeyarwady River.

Outputs: (1) 60 trained tour guides, tour operators and boat owners. (2) Published manual for workshop and for operating on the river

Follow-up: To ensure the protocols are implemented, there will be: (1) leafleting of boat operators, tourist police, Inland water authorities, UMTA (Union of Myanmar Tourism Association) and MTF (Myanmar Tourism Federation) members with a summary of guidelines; (2) informal policing through social media (to be launched in November, 2015).

Output 1.2a:

Activity: Workshop with village committees in Hsithe and Myitkangyi (7-14 May, 2015) Organised and led by: Paul Bates/Beatrix Lanzinger, Harrison Institute, Dr Sai Sein Lin Oo of University of Mandalay and Aung Chan Phyo of Grow Back for Posterity.

Supported by: Darwin Initiative (financial) and Harrison Institute, University of Mandalay and Grow Back for Posterity (logistics and participatory support).

Objective: To develop environmental guidelines (especially relating to waste management, pollution and fishing practices) for new destinations for river boats on the Upper Ayeyarwady. **Outputs**: Greater awareness amongst villagers of the importance of environmental management.

Follow-up: Simple guidelines for villagers formulated. These must have a realistic chance of being adopted and adhered to.

Output 2.1a

Activity: Field studies in May, 2015 (complementing those previously conducted in May, August, October-November 2014 and February, 2015) provided data for TAPs (Tourism Assessment Process)/master plan for 3 new destinations (the fishing villages of Hsithe and Myitkangyi and the Wildlife Sanctuary and associated communities of Tawyagyi-Sheinmaga). Draft TAPs have been prepared as discussion documents.

Organised and led by: Paul Bates/Beatrix Lanzinger, Harrison Institute in conjunction with Aung Myo Chit of Grow Back for Posterity and Dr Sai Sein Lin Oo of University of Mandalay. Supported by: Darwin Initiative (financial) and village communities, Harrison Institute, Grow Back for Posterity, and University of Mandalay (logistics and participatory support). Objective: To assess the viability of three destinations to host national and international tourist visits by way of river boats in order to promote poverty alleviation and the conservation of the critically endangered Irrawaddy River dolphin and the endangered Eld's deer Outputs: Draft TAPs for the three destinations.

Follow-up: Launch of two (Hsithe and Mytikangyi) of the three destinations to tour agents, boat operators, tour guides, local authorities and the media in March, 2016; operation as destinations to commence with launch of high season (post monsoon, April-October) in November, 2016.

Output 2.2a

Activity: No study visit to other ASEAN examples of CBT (Community-based tourism) was undertaken. Rather, three of the project team (Paul Bates and Beatrix Lanzinger of Harrison Institute and Dr Thein Aung of Myanmar Bird and Nature Society) attended 'An International Conference on Ecotourism in Protected Areas: strengthening livelihoods, conservation and adaptation', which took place on 19-21 May, 2015 in Nay Pyi Daw, Myanmar - http://www.icimod.org/?q=18307. This brought together delegates from throughout Southern and South-east Asia, together with other experts from Europe, the Americas and Australia.

Outputs: (1) Numerous examples of good and bad practice in Asia/worldwide of implementing CBT projects that endeavour to support poverty alleviation and wildlife conservation. (2) Networking with Ministers, senior government officials, protected area staff, conservation CSOs and NGOs, international experts, local experts, tour operators, and international donors.

Follow-up: Use information to ensure best practice in the destination development component of the current project.

Output 2.3a and b

Activity: Ideas for the website are currently evolving through on-going discussion with our CSO partners, tourist trade organisations and the conservation community. To date, we have developed two websites for our principal project partners: Grow Back for Posterity - http://www.growbackposterity.com/ and Myanmar Bird and Nature Society - http://www.myanmarbirdnaturesociety.com/.

Background: The title, aim, objectives and information provided on the final project website have to still to be finalised. Initially it was envisaged as a local website highlighting the work of the project with some additional information about tourism on the Upper Ayeyarwady River. Currently (dependent on on-going discussions with the Myanmar Tourism Federation), we wish to broaden its scope to that of a national website to promote nature tourism/ecotourism to Myanmar, such as for Lao http://www.ecotourismlaos.com/. Our favoured format is that adopted by Zambia with their website http://www.zambiatourism.com/.

Follow-up: Finalise the website concept and publish by November 2015.

Output 3.1a

Activity: A training programme for ecotourist guides/bird watching guides took place between 14 September and 17 October, 2015. Twenty-eight individuals joined the course, of which 24 successfully completed it.

Organised and led by: Dr Thein Aung of the Myanmar Bird and Nature Society.

Supported by: Darwin Initiative, Htoo Foundation, Htoo Zoos and Gardens Business Unit, and individual subscription (financial) and Myanmar Bird and Nature Society and Wild Wings Photography Group, (logistics and participatory support).

Objective: To train a new generation of tour guides in the concepts of ecotourism, conservation and bird identification.

Follow-up: To publish details of trained guides who wish to be included on the new Myanmar ecotourism website.

Output 3.1b

Activity: Poor internet access has prevented the online training of two students in 'Sustainable Tourism Management'. On 22 October, 2015 discussions will be held with the Myanmar Tourism Federation to determine if resources should be channelled through them to train two students or whether the money should be invested in developing a website for Myanmar ecotourism (see discussion above).

2a. Give details of any notable problems or unexpected developments/lessons learnt that the project has encountered over the last 6 months. Explain what impact these could have on the project and whether the changes will affect the budget and timetable of project activities.

There was severe flooding in Myanmar (July – September, 2015), including in Sagaing Division https://en.wikipedia.org/wiki/2015 Myanmar floods . As such, two of our proposed destinations were reported by the Myanmar Darwin team as inundated. Currently, we do not know if this has on-going implications for the project but will assess the situation on 28 October when we visit these communities as part of our new season of field work.

On 8 November, 2015, Myanmar is having a general election. Depending on the processes and outcome, it is possible that this may have implications for the project. Currently, the government has banned all workshops in November involving university staff and students. They have also recently banned the signing of MoUs between NGOs and universities (indefinitely). This has affected our ability to sponsor directly two students to undertake training in 'Sustainable Tourist Management'.
