1. Outline progress over the last 6 months (April – Sept) against the agreed baseline timetable for the project (if your project has started less than 6 months ago, please report on the period since start up to end September).

Report 1st April-30th Sept 2016

1.1 A priority species list was developed from literature review April-June, and reviewed at the Inception workshop June, when 17 additional species were added, to total 467 species, c.50% greater than the c.330 anticipated in the baseline timetable.

10 candidate priority habitats were identified for and reviewed at the workshop (c.9 had been estimated), and 20 candidate IPA sites (32 had been estimated). Modifications will be made as data collection from fieldwork proceeds, and the number of IPA sites is expected to rise.

1.2 c.2000 records of candidate threatened species were accumulated from herbarium and literature up until end Q2 (c.3000 were estimated to be needed in total by the end of the project).

1.3 Four targeted field surveys were conducted in June: Coyah-forest islands; Kindia-Mt Gangan area, Kolente area, Central Fouta Djalon Highlands (Dalaba-Labé). In late September parallel surveys were conducted in Kounounkan and the Kindia sandstone bowal areas.

1.4 Mapping of sandstone and ironstone bowal habitat (two of the priority habitats) together with detailed species characterisation was initiated in April as part of a Masters project by Natalie Konig (supervised by the PL and Jenny Williams, SA researcher supported by Charlotte Couch) and ground-truthed in June.

1.5 Full IUCN assessments were compiled on SIS for 29 species, of which 12 appeared on the new release of the IUCN website in June 2016, and a further 25 are expected to appear in the Dec. 2016 release.

1.6 Formal application of IPA criteria will begin to be applied to the first candidate IPA sites in Q3. 2.1a In May the PL and main project partner publicized the Guinea IPA Darwin project by speaking at a meeting funded in part by the International Finance Corporation, of extractive companies and biodiversity players in Conakry, Guinea.

b. Key stakeholders were engaged at the Inception workshop in Conakry in June, which was well attended by about 30 persons including the CBD focal point Col. Abouboucar Oulare and the Head of the National Protected Areas Unit, Paul Guilavogui. The event was filmed and the PL interviewed on the project for national television on three occasions. Each time coverage then appeared on all national tv news programmes evening and morning. The opening workshop was closed by the Minister of the Environment, Water and Forests (MEEF), Christine Sagno, with the British Ambassador also present..

3.1 Gathering of materials for a training booklet on Guinea's plant diversity, the IPA approach, and species redlisting began in Q2.

3.2 An IPA site data recording sheet was developed from a Plantlife template in Q1.

3.3 Lectures and reading material on species-based and site-based conservation were developed in Aug-Sept for delivery to the UGAN MSc in Oct.

3.4 Preparations were made for Dr Magassouba from HNG and Saidou Doumouya (MEEF) to visit Kew for training in and to make progress with data capture and georeferencing in November-December. Training in redlisting in SIS will also be given.

3.5 Discussions on student projects covering socio-economic species have taken place in Q1-2 with the staff at UGAN.

3.6 Design of posters for a National Flower campaign, after discussion with Ben MacCarthy of Plantlife at Kew in July, began in Sept and has proceeded with feedback from Guinean partners.

3.7 Discussions with GE regarding their hosting of a Teachers' Training workshop began in June during joint fieldwork, and continued by email in Sept.
