1. Outline progress over the last 6 months (April – Sept) against the agreed baseline timetable for the project (if your project has started less than 6 months ago, please report on the period since start up to end September).

The project has continued to run according to the project plan over the last six months.

#### Stakeholder consultations:

In the first year of the project, the consultations were focused on *ex situ* collection holders. In the second year we have focused on researchers, with two significant consultation sessions held involving nearly 50 researchers from Universities and research institutes across Ethiopia. With the help of an expert facilitator from Kenya, these consultations have addressed a range of issues related to Access and Benefit Sharing (ABS) and how ABS implementation affects the work of plant researchers in Ethiopia. Key issues have emerged, such as lack of awareness of the Ethiopian ABS framework amongst young researchers (MSC and PhD students), concern about plant materials that are taken out of Ethiopia for research purposes and a lack of understanding of when the International Treaty on Plant Genetic Resources for Food and Agriculture should apply instead of the Nagoya Protocol. Amongst the recommendations coming from these consultations for the project to consider taking forwards are the following:

- developing materials for training the trainers in Universities to help MSc and PhD students understand ABS issues
- Looking at ways to facilitate input by researchers into the updating of ABS legislation in Ethiopia
- Building capacity of researchers to become intermediaries in raising awareness of ABS issues at the local community level.

These recommendations will be taken into account as we develop capacity building materials within the framework of the project. In this respect, we have held in-depth discussions with the staff of the Ethiopian Biodiversity Institute's ABS Directorate on the development of relevant capacity development materials to support these staff.

Consultations have also been held with staff involved in the 'UNDP/GEF Global ABS project 'Strengthening human resources, legal frameworks and institutional capacities to implement the Nagoya Protocol' and the Regional Coordinator for Africa is now part of the project's International Steering Committee. Similarly, discussions have been held with the genebank manager and staff of the International Livestock Research Institute which is located in Addis Ababa to understand the relationship between the international centre and the Ethiopian government.

# Compile examples and case studies of best practice on simplified measures for access from around the world

The project consultant has made a wide-ranging study of existing practices and has identified a number of relevant case studies. These are in the process of being written up and will be available on the project website shortly. It is notable that such case studies are relatively rare and this activity has proved more time consuming than originally anticipated.

#### Promoting the project

The project was presented in two sessions held at the 6<sup>th</sup> Global Botanic Gardens Congress in Geneva in June 2017. The first was a session focused on Darwin Initiative projects, where a presentation was made on the project itself.

The second event was a symposium on ABS where the initial results of the project were presented, together with presentations on ABS from other countries around the world.

Both were well attended events and served to raise awareness of the project activities. The ABS symposium also allowed the Ethiopian project partners to interact with others involved in implementing ABS in other countries. Of particular interest was a presentation from Mexico introducing the new Code of Conduct that has been developed for *ex situ* collection holders, providing guidelines on how to interact with local communities when collecting plant material.
