1. Outline progress over the last 6 months (April – Sept) against the agreed baseline timetable for the project (if your project has started less than 6 months ago, please report on the period since start up to end September).

- All the workshops to identify sites for the *in situ* and *ex situ* conservation of crop wild relatives that were rescheduled for Y3 Q1 took place in the collaborating countries on the following dates: Mexico City, Mexico, May 28-30, Antigua, Guatemala, July 4-5, and San Salvador, El Salvador, July 9-11. During these workshops the sites to collect germplasm were also identified.
- The second part of the webinar to homogenise passport information and provide guidelines on the collection of crop wild relative germplasm material took place on 6 September 2018 for 5 partners with 12 participants.
- In preparation for the field expeditions collection permits are underway in Guatemala. El Salvador and Mexico have permits in place.
- The camera interviews with experts for the video have been completed and the poster is being designed.
- The field expeditions will start in November in all three countries.

2a. Give details of any notable problems or unexpected developments/lessons learnt that the project has encountered over the last 6 months. Explain what impact these could have on the project and whether the changes will affect the budget and timetable of project activities.

Due to personnel changes, it was not possible for the collaboration institutions in Honduras to reach an agreement on time to run the planned workshops with the same elements as in the other participating countries. However, there is interest from Honduran experts to receive training on the use of the methodology to assess the extinction risk of species. If the associated change request is accepted, this workshop will take place in the week of the 18th of February 2019.
