1. Outline progress over the last 6 months (April – Sept) against the agreed baseline timetable for the project (if your project has started less than 6 months ago, please report on the period since start up to end September).

All activities scheduled for the period April-Sept 2018 have occurred as planned (but see our reply to 2a).

## **Output 1: Fisheries and livelihoods**

- 1.1-1.4. Fisheries landing surveys are ongoing. Updated summaries of fisheries surveys and mapping areas are being produced. In April, we started a maturity study of the Golden African Snapper (*Lutjanus fulgens*) in partnership with Forever Principe a conservation tourism program by <u>Africa's Eden</u>. Every month, samples (fish gonads, fins, otoliths and stomach content) are collected and will be used to better understand the biology of this species and inform fisheries management. From 16<sup>th</sup> July 16 to 10<sup>th</sup> August, we completed the first round of surveys using BRUVs (Baited Remote Underwater Video surveys) to record fish presence and relative abundance; sixty sampling points, randomly selected, were surveyed and over 90 hours of videos have been recorded. Data on marine habitat types was collected using remote sensing and field samples from 1<sup>st</sup> August to end of September.
- 1.5-1.6. Following selection and implementation of project interventions during Y2, infrastructure for all community initiatives was ready by May. Documents delineating management model for each specific initiative (produced together with local communities) were all approved and signed in July. During the month of August, two of our community initiatives (handicraft centre at Praia Burra and handmade soap production by fisher and fish traders from Praia Abade) participated at the Príncipe Island Entrepreneurship Fair; this was a regional initiative to showcase local products and projects. Another project initiative, Lapa's community headquarters, was inaugurated on the 16<sup>th</sup> June with the presence of the President of the Regional Government of Principe Island. The six community interventions have been closely monitored and support provided when needed. For example, among the four income-generating interventions, two of them have already started splitting revenues among beneficiaries. Project support was been particularly relevant in terms of assisting financial decisions (e.g. estimate profits and decide about revenue sharing).

#### **Output 2: Establishing co-management**

2.1. As part of the "community ideas" initiative, we are identifying key opportunities and challenges for implementing fisheries co-management. While our project has been focusing on developing community capacity and laying foundations for co-management, this will not be achieved with timeframe of project (see our reply to 2a); we have spent considerable time assessing capacity and potential mechanisms but the process is too incipient. Ensuring our project activities are, however, fully sustainable, we are working towards smooth transition into a recently funded project approved by Blue Action Fund; this will carry on and expand our activities, and will have establishment of co-management for marine conservation as one of key goals.

### Output 3: Ecosystem services trade-offs and social spill-over effects

3.2-3.4. Summaries have been produced based on data collected in Feb-March 17 for posterior comparison with information to be collected in Jan-Feb 2019.

### **Output 4: Capacity**

4.1- 4.4. From 1<sup>st</sup> August until 9<sup>th</sup> October, Dr Benjamin Cowburn joined our team as volunteer and undertook research to identify and map marine habitats in Principe. Thanks to a new collaboration with University of São Tomé, a local BSc Biology student is undertaking her dissertation work with us. She started processing information in September and is expected to deliver her BSc dissertation by end of December, allowing her to successfully graduate. In addition, a recent BSc graduate from University of Aveiro (Portugal) is undertaking an internship with us, thanks to Erasmus+ funding.

Following on selection and implementation of project interventions during Y2, some complementary training was delivered during April-Sept 2018. In collaboration with the Sao Tomean NGO Marapa, we held training on small business management on the 26th of April; the fish traders association of Praia Abade (all women; N=15 participants) participated in this training to learn how to better manage their financial resources. On the 30th and 31st of May, fish traders and fishers from Praia Abade (N=7 participants, among which 4 were women) learnt how to produce handmade soap using locally produced coconut oil. In June 2018, our research assistant Guillermo Porriños was trained on histological techniques (mounting and staining fish gonads samples and observation in the microscope); training was delivered for eight days (80 hours) by Dr Anke Lange in Prof Charles Tyler's laboratory at UoE.

4.5 - 4.6. Following our Y2 work on assessing options to mitigate the impacts of illegal, unregulated and unreported fishing on São Tomé and Príncipe, we have now donated an AIS server to the National Fisheries Department (thanks to MarineTraffic.com). This is now been fully installed and has been working since 15<sup>th</sup> August. This substantially increases national capacity to detect and potentially control industrial fleets passing through Sao Tomean waters.

#### **Output 5: Project monitoring and evaluation**

In addition to weekly or biweekly meetings with local communities, key meetings with project partners and local stakeholders to discuss project progress have been held on: monthly meetings between PTF and government representatives; 15<sup>th</sup> August (UoE with National Fisheries Department); 16<sup>th</sup> August and 10<sup>th</sup> September (UoE with University of São Tomé); 18<sup>th</sup> September (UoE with Marapa and Programa Tatô, Sao Tomean NGOs); 21<sup>st</sup> September (UoE with Regional Fisheries Department). Preliminary project findings have also been presented and discussed at IV Biology Conference in São Tomé (21-25 May) and the first meeting of the Abidjan Aquatic Wildlife Partnership in Abidjan, Ivory Coast (23-25 July). Regular (approx. once a week) presentations to international tourists have been delivered at one of Principe's high-end resorts. A focal point from the National Fisheries Department also traveled to Principe island to visit the project, provide feedback and act as facilitator among departments from 27<sup>th</sup> to 30<sup>th</sup> September. In addition, UoE/PTF meetings have been held in person or by skype at least once a week.
