1. Outline progress over the last 6 months (April – Sept) against the agreed project implementation timetable (if your project has started less than 6 months ago, please report on the period since start up to end September).

We are towards to end of the project. In terms of activities, most of the activities were completed within projects regular life (Project was supposed to end in May 2022). However, some of the activities could not be completed in projects originally agreed time mainly due to COVID-19, and they were transferred to extended time (until March 2023). This report presents activities undertaken during April-September 2022. Progress against relevant Activities under each outputs have been presented. Figure in the parenthesis represent the activity number from the time table and supporting reports have been cited if applicable.

Output 1 Forests are sustainably managed with greater diversity, enhanced structural complexity and improved productivity, and institutional capacity for biodiversity conservation enhanced

Royal Botanic Garden Edinburgh (RBGE) Field expedition (Which lagged behind due to covid-19 was organised in the leadership of Dr, Mark Watson in September 2022 (1.7, Doc 01). Earlier Dr Bhaskar Adhikari and Axel Poulsen from RBGE also visited Jalthal for Botanical exploration.

Output 2 Mikania invasion substantially reduced and controlled, degraded forest areas and wetlands reclaimed and converted into productive systems through 'site management'.

Several meetings were organised at local level to plan and carryout Mikania removal (2.2, Doc 01, 02). Mikania and other invasive species have been removed from over 31 hectares of Degraded forest (2.3, Doc 02). The project has piloted production of compost by using biomass of invasive species. Five Community Forest User Groups (CFUGs) have been initiated production and use of compost. Some CFs already started generating cash by sell of compost (2.4, Doc 02, 03). Agroforestry has been piloted in Mikania controlled areas and a satisfactory result have been achieved in growing shade crops and trees (2.6, Doc 03). The results will be shared as a blog soon. Awareness programs have been organised to local people and students on biodiversity conservation and invasive species management (2.7, Doc 01). A biodiversity infographic, which highlights conservation significance, of Jalthal forest has been published in both English and Nepali language and disseminated both in print and online (2.8, Doc 04). A special issue of *Hamro Ban Sampada*-a magazine about forest management in Nepali language-will be published before end of the December. This will be a major output towards knowledge management of this project.

Output 3 Biodiversity conservation and values are appreciated and integrated into community forestry policy and planning process; communication materials highlighting biodiversity conservation prepared and disseminated for diverse stakeholders

Most of the activities towards this output have already been completed. A seminar will be organised during January-February 2023.

Output 4 Forest based micro enterprises including ecotourism facilities established and operationalized for enhancement of local livelihoods

We have supported a group of women who are practicing traditional weaving of clothes. They are provided with necessary materials so that their production capacity and market access will be increased (4.6, 4.7, Doc 01, 02).
