#### Output 1: Activities

**Activity 1.1** Conduct targeted biodiversity surveys, with participation from IPs, of wildlife and key habitats to provide the knowledge for an evidence-based zonation and management plan (Y1).

Completed. See attached report. A total of 2,494 independent events were recorded over the course of the survey, comprising 59 species; 36 mammal, 21 bird and two reptile species. 647 records could not be identified beyond family and were excluded from the species list and species richness. Of the 59 species detected, 16 are categorised as Threatened on the IUCN Red List: three Critically Endangered, two Endangered and 11 Vulnerable. A further three species are Near Threatened.

Activity 1.2 Disseminate results of biodiversity surveys to raise awareness and galvanise a sense of pride nationally, and to augment political will (Y1-Y2).

Virachey camera trapping report has been shared with the Ministry of Environment and Provincial Departments of Environment in Ratanakiri and Stung Treng. Video of the elusive, Critically Endangered large-antlered muntjac was recorded for the first time anywhere, confirming the presence of multiple individuals of the species. The recent findings confirmed the importance of Virachey National Park for this species. The results of the survey were presented during the national stakeholder consultation workshop on zoning in June 2023. (Please see the report attached)

**Activity 1.3** Conduct participatory zonation consultations with MoE, IPs and other stakeholders, to inform a zoning of VNP that fulfils conservation needs and IPs' sustainable resource use rights (Y1-Y2)

In progress. On 5 June, 2023 Fauna & Flora supported the Ministry of Environment to organise the national zoning consultation workshop, where 50 key stakeholders at the national and subnational levels were invited to officially validate the zonation results for government endorsement. The workshop fully agreed on the final draft zonation map for Virachey National Park including 134,417 ha for core zone, 109,293 ha for conservation zone and 87,908 ha for sustainable use zone and 882 ha for community zone. (Please see draft zonation map attached). However, in July 2023 the government expanded the area of Virachey National Park from 332,500 ha to 405,766 ha. This expansion has resulted in the need to zone the expanded area before approval of zonation by the Prime Ministerial Sub-Decree can be completed.

Activity 1.4 Develop an evidence-based management plan in partnership with MoE, following best practice guidance and with input from indigenous communities (Y2-Y3).

No reportable progress as activity depends on the finalization of the zonation for the park. MoE have requested that work on the management plan follows the zonation.

#### **Output 2 Activities:**

Activity 2.1 Assess current CPA management practices, customary institutions, land tenure and resource use need within four CPAs in Ratanakiri Province (Y1).

Completed.

Activity 2.2 Strengthen technical and organisational capacities of existing CPA Committees to update, implement and monitor existing management plans, and to engage in relevant decision-making (Y1-Y2).

In progress. Several meetings were organized at the village level to select candidates to stand for election to be CPA committee members to follow the CPA management guideline and ensure the transparency. There were 85 with 18 females were selected by the CPA members in the community as the candidates.

The CPA committee member's election event will be organized by the PDOE in collaboration with Fauna & Flora in November 2023 to officially finalize the selection. The official Deika (commune level) for the recognition of CPA committee members will be issued by the commune council.

**Activity 2.3** Support the revision and monitoring of CPA management plans to ensure effectiveness and equitable distribution of risks/costs/benefits (Y2).

In progress. Fauna & Flora and our partner NTFP have undertaken a literature review and updated some key sections of the previous CPA management plans based on the availability of relevant data. The full revision process will be initiated after the final selection of CPA committee members which is scheduled for the completion in early December 2023 and will be discussed during the second gender-inclusive workshop to be scheduled in late December 2023.

**Activity 2.4** Train and support CPA members to conduct monthly forest community patrols to record, remove and discourage threats to wildlife, in line with CPA management plans (Y2-Y3). Completed. However, the project plans to continue providing additional training and support to new CPA committee members after the selection by election.

**Activity 2.5** Deliver two gender-inclusive workshops per year per target community within CPAs on regulations in protected areas including cultural and scientific contextual components (Y1-Y3).

9-18 August 2023, the first series of gender inclusive workshop under the theme of "The Importance of Virachey National Park and Gender Integration Community Protected Areas' was successfully organized by our partner NTFP in collaboration with PDOE and Fauna & Flora to 4 CPAs located in Veun Sai and Taveng districts of Ratanakiri province. 150 participants (70 women) attended the series of workshops for all 4 CPAs. The workshop built their understanding about key values of the park and provided opportunity for them to learn and share their knowledge, experience and challenges in protecting Virachey National Park to have better CPA management plans. Please see report attached.

The second gender inclusive workshop is scheduled for December 2023 to build capacity and ownership of indigenous communities in developing their new CPA management plans for year (2024-2028).

**Activity 2.6** Support 4 youth eco-clubs to take an active role in conservation stewardship within their communities through capacity building and local awareness events (Y1-Y3). Ongoing.

### **Output 3 Activities**

**Activity 3.1** Analyse and monitor gendered aspects of natural resource use, disaggregating roles in livelihoods and community decision-making processes to ensure gender-responsive project delivery (Y1).

The project has developed a methodology for conducting a research study on gender in natural resource management.

The project has conducted the field assessment, looking at the current roles of women in the use and access to natural resources and CPA management governance system, key challenges and barriers to their participation and opportunities the project should be aware of and recommendations to ensure the gender-responsive interventions for the better impacts on gender role in natural resource management. The key results from this analysis will be used to inform the updated CPA management plan and livelihood strategy development. The gender analysis is scheduled for completion in November 2023 and will be available in the next reporting.

**Activity 3.2** Analyse community socio-economic status and assess traditional and current agricultural and NTFP/wildmeat harvesting practices, and cultural values (Y1). The project has completed the field assessment and results are being analysed. The report will be available by March 2024. While the final report is being finalised, we are integrating information gathered to help advise ongoing activities.

**Activity 3.3** With IPs, identify and evaluate strategies based on conservation goals, agroecological conditions, traditional practices, existing skills/interests, and market demand based on market system analysis (Y1). Completed.

Activity 3.4 Deliver technical training and develop capacity for indigenous producers for climate-smart agriculture, poultry, and revitalisation of sustainable traditional NTFP harvesting (Y1-Y3).

In August the project collected 200 malva nut seedlings from O' Kapha CPA for grafting in the nursery in order to make a planned clonal grafting during the fruiting season from March-May. The grafting assessment found that there is 99% of survival rate.

The planned clonal grafting trial during the fruiting season is important and promising from the local communities as they are interested to grow them within their own CPA territories. If the

trial is successful, the malva nut trees will be grown within the CPAs and local private lands. It is expected to provide significant benefits to local livelihoods as malva nut is a seasonal major source of income with very good price on the market and reduce pressure on malva nut trees inside the park. In the meantime, the project has also worked with local communities to ensure the sustainable use and collection of malva nuts in the park.

Activity 3.5 Improve market access for selected agricultural and NTFP goods through better linkage between target communities and private sector and development of processing unit if feasible (Y1-Y3).

As part of the broader activities on improving market access, the project has identified several potential buyers located in Banlung provincial town of Ratanakiri province for malva nut, cobra mushroom and cashew nuts. In the common practice, the community, district and provincial traders were unofficially connected to each other in terms of trading, which has led to unstable price for local products. In the meantime, the project has supported local farmers to improve the quality and quantity of the selected malva nuts and cashew nuts. The project has been engaging in discussion with buyers on the possible potential linkages and connection with local communities. The project plans to bring together interested buyers and CPAs to coordinate the initial discussion about the interests and partnership.

2. Give details of any notable problems or unexpected developments/lessons learnt that the project has encountered over the last 6 months. Explain what impact these could have on the project and whether the changes will affect the budget and timetable of project activities.

- July 2023 witnessed a major change in protected area system in Cambodia, affecting 37 protected areas across the countries. Boundaries of most of the PAs bordering biodiversity conservation corridors were changed by sub-decrees dated on 17 July 2023, most of which have increased in sizes because of merging biodiversity conservation corridors into the PAs. A total of about 1,216,090 hectares from biodiversity conservation corridors were added to Cambodia protected area systems. The boundary of Virachey National Park was revised, leading to an increase in size from 332,500 ha to 405,766 ha. Parts of the new park areas are occupied by communities and have been degraded. However, the park expansion has been carried out without sufficient engagement with the indigenous peoples and local communities. Fauna & Flora are working to understand the implications of this decision, especially with regard to community members and in the context of social safeguards. Further details on this matter will be included in the upcoming annual report.
- This expansion has affected the zonation process over the old boundary of the park, which has led to the delay in the approval of zoning by the government.
- The project leader Garry Allen Shea, who managed this project, has passed away. A change request reflecting project leader change will be submitted.
