1. Outline progress over the last 6 months (April – September) against the agreed project implementation timetable (if your project started less than 6 months ago, please report on the period since start up to end of September).

The overall Y3 activities during April – September 2024 have been working in line with the project timeline contribute to the long-term outcome. The final measurement of outcome indicators will be measured by EoP. However, we will also describe the general picture of outcome within each output as below:

<u>Output 1: Reduced direct threats to forest habitat and rare - threatened species, through effectively operating joint Protection & Monitoring Units (PMU)</u>

Most of indicators on output 1 has been achieved by Y1 and Y2. This Y3, our activities are focused to achieve indicators 1.4 and 1.5, i.e. continuing SMART patrols and species target monitoring on each Village, as well as supporting one joint patrol. During March - September 2024, four (4) PMUs (20 men) conducted 18 forest patrols (90 Days) covered 205.25 Ha or 59.5% and recorded 39 threats including zero fires (Activity 1.7). This progress is recorded 9% threats reduction incl. 100% reduction of fires compared to baseline (outcome indicator 0.2). In July 2024, the patrol team (13 people) monitored orangutans and target species in the Rantau Panjang Village Forest using camera traps and in the GPNP area (Riam Berasap). Orangutan density was recorded 0.32 ind./Km2 in Rantau Panjang and 3.5 ind./Km2 in Riam Berasap. The camera trap also recorded 1 ind. of Sunda pangolin in Rantau Panjang. The remaining patrol will remains continue until EoP, including the joint patrol that is planned to deploy by January 2025.

Output 2: 11,223 people in four communities around Gunung Palung have improved resilience to climate change through improved prevention and management of fires, water table management, and peat swamp forest rehabilitation.

This Y3 activities are focused targeting on indicator 2.1 and continuing indicator 2.3, which is still in line with our project timeline. During March to October 2024, hotspot monitoring using NOAA analysis identified 9 hotspots in the GPNP area, a reduction of 1.6% from the Baseline (indicator 2.1) contribute to reduce 98% of fire hotspots (outcome indicator 0.3). Besides, after the construction of 7 canal blocks in Y2 (Activity 2.3), water level measurement was monitored in wet season (June) and dry (August) season (9 points). The average water level in June was 27.3 cm (flooded), while in August (dry season) was 21 cm (flooded). This result demonstrates that canal blocking is effective in rewetting the peat ecosystem. Rehabilitation is on progress through continues planting in the restoration area in August 2024 (Activity 2.7), totalling 8,733 seedlings (7,665 forest trees and 1,068 MPTS). The planted monitoring in September 2024 recorded the seedling survival rate of 63.47%. The factor that causing the dead seedlings are still investigated but most likely due to the flooded. We learned also that the effective of canal blocking in rewetting ecosystem may led to selective seedling species for planting. We will adjust to select the flood-resistant seedling species on the next planting by November 2024, of which will completing output indicator 2.3.

Output 3. Capacity of at least four community groups representing 500 households (>3,000 people) is increased to diversify livelihood opportunities based on biodiversity-friendly products

This 3rd year are focusing on indicator 3.5 to improve values chains leading to increase income of community groups, while also conducted assistant to monitor the overall output 3 indicators incl. 3.1, 3.3 and 3.4. During March - September, monitoring of financial management, monitoring of productivity improvement in 9 business groups of 184 households (99 M: 85 F), the next period there will be 5 business groups to be monitored (Indicator 3.1). The monitoring results showing income increase compared to last year of each group, such as 79% for wicker groups, 77% for horticulture, and 13% for coffee, while the chips and stingless-bee honey groups have just produced products in this year (Indicator 3.5). In May 2024, assistance to increase the productivity of business groups was provided to make organic fertilizer in 3 business groups and provide support for horticultural seeds in 7 business groups (Indicator 3.3). Until September 2024, the total HH who has new access for sustainable financing from improved value chain was 320 HH (outcome indicator 0.4), with increased income mostly more than 20% than last year monitoring (outcome indicator 0.6).

<u>Output 4. Two village forest institutions have secured long-term funding (at least 10 years) for PMU operations to protect village forests and contribute to community wellbeing</u>

The Y3 activity in output 4 are focused on preparing the documentary to assess domestic carbon market following the new regulation, that enabling the mechanism of domestic carbon market and carbon offset. The draft mitigation action plan document (DRAM) as the requirement to register domestic carbon market has been prepared by August 2024. The DRAM will be socialized to stakeholders for input and revision prior to submission by LPHD, which is expected prior to EoP.

#### Monitoring of assumptions

We have identified the assumptions in each output, and we believe the overall assumptions are still valid.

- The construction of 7 canal blocks greatly affected the expected water level to reduce the threat of forest and peat fires. This effort, using the simple blocking method has effective for rewetting of peat ecosystem and prior to restoration planting.
- Since the rewetting of peat are effective, planting seedlings then become our challenge to restore the forest by selecting appropriate species resistant to flood.

This permit allows Fauna & Flora to continue operating in Indonesia until the new technical agreement being signed for the next 3 years period.
