In HY2 good progress was made and we were able to catch up with the delayed implementation of some activities in YR1.

With the supervision of our Assistant Project Manager (Patrice), 12 seed collectors continued to collect high quality and vouchered samples of seeds (Activity 2.4). These were dispatched to the project office at Sakaraha (3.3) where the young entrepreneur (Rado) accessioned these collections and a) sent a subsample to the three nurseries for propagation and b) stored a sub sample in the newly installed storage facilities (for sale) (2.4). In total 181 kg of seeds of 11 different native tree species are currently in storage. With our help, Rado recruited two local assistants (Germain who is responsible for accountancy and client interface; and Fabian who is responsible for facilitating the relationship with FRAM, paying the salary of the teachers that we support, and management of stock) – together this team make up the business unit (3.4). To date 2,427,500 MGA has been generated from the sale of seeds. These funds have not yet been used to support teaching. To add value to our seed samples, in June we engaged a consultant who was tasked with calculating the wood density of each of the target species (2.7). The report is available here

The 12 nursery women have continued their work in the 3 nurseries and currently 4,306 seedlings of 17 target species have been potted-up (2.4). The ability of these species to

survive and grow in degraded habitats will be evaluated in trials that will be installed at the start of the wet season in December 2023. The three trial locations have been identified (2.5). We have continued to support the parents to support 8 teachers at 3 different schools (1.4). Our monitoring shows that these teachers are present and active but, at one of the schools (Andranoheza), student attendance is sporadic (see below). 2. Give details of any notable problems or unexpected developments/lessons learnt that the project has encountered over the last 6 months. Explain what impact these could have on the project and whether the changes will affect the budget and timetable of project activities. There is an unusual degree of animosity between neighbouring villages in the landscape surrounding the Analavelona Protected Area. This probably stems from a long history of "tit for tat" cattle-raiding between villages. We were able to implement this project at three villages only and some of the people in villages that were not beneficiaries were jealous of those who did benefit, and angry with us. This was not unexpected and has been managed to a certain extent by enabling especially motivated teachers to provide courses during holidays for students in one of the villages where parents were particularly unhappy. Conversely, at one of the villages that did benefit from the provision of four part-time teachers (and also had excellent school infrastructure provided by a previous project), student attendance was inconsistent apparently, according to parents, because they needed their children to work in the fields... "if they don't work then they will not be able to eat". The lesson learnt is that the lamentable level of education in much of rural Madagascar is not merely due to lack of infrastructure and lack of properly trained and motivated teachers, but also due to deep food poverty that turns schooling into a luxury accessible only to the relatively well off. Theoretically we could address food poverty by providing a school canteen but, in reality, such an action could not be accommodated, at least on a daily basis, within our budget. However, it might be possible to generate sufficient funds from the sale of seeds to provide a canteen once a week and then concentrate teaching effort on this day. 3. On 23 August I sent this message to Eilidh Young

Dear Madam

I am writing to ask you advice on the following matter. The site office for the project "Valorising Malagasy protected areas as seed sources for forest restoration" is in a town called Sakaraha in south-west Madagascar. This town boasts just one bank "BOA" and it is here that we transfer funds for field activities after their receipt by our central office in Antananarivo. However, BOA has a policy not to establish accounts for US organisations (such as us – Missouri Botanical Garden) and therefore we set up an account in the name of one of our project staff from which funds can be accessed by a cheque with two signatories (both local staff). However, in retrospect, we think this arrangement may not be acceptable to the Darwin Initiative. The nearest alternative bank is a 4 to 5 hour journey to Tulear such that a withdrawal would result in the loss of two days of work and result in additional travel and subsistence expenses. I should add than funds are transferred from Antananarivo following receipt and validation of an expense report for the previous advance and in line with an itemised request for a new advance. I wonder whether this situation is acceptable to you or whether you would prefer us to use an "MBG-named" account based in Tulear?
