Output 1: Profiling the problem and building evidence

Monitoring of HEC in and around Project village: We continue to regularly monitor elephant movement and human-elephant conflict (HEC) incidents that occur in and around the project villages through active participation of the project team members, village champions (VCs) and Rapid Response Units (RRUs). In the last 6 months, we recorded 13 incidents of crop damage from eastern Assam, and 10 incidents of property damage from both Assam and Meghalaya project villages (Details in Annexure 1). Three human deaths (non-residents of project villages) were also recorded around project villages of West Garo Hills in Meghalaya during the reporting period. Data analysis and report writing: The project team has analysed the data collected in the last 2 years and shared the findings with concerned stakeholders. A total of 20 village meetings were organised in eastern Assam and Meghalaya to update the stakeholders regarding various activities performed. The information is available on request.

Output 2: Promoting security for people and elephants by raising awareness

<u>Developing IEC materials:</u> During this reporting period, an audio-visual form of the existing IEC material of "Gajah Katha" Phase I was made and launched on World Elephant Day on 12th August.

Moreover, a handbook was published in local Assamese language on human-elephant conflict mitigation tools of community managed solar-powered electric fences. This book was launched by Ms. Nandita Garlosa, Honourable Cabinet Minister for Power, Sports & Youth Welfare, Co-operation and ITFC (Archaeology) Department, Government of Assam, at an event held in Guwahati, Assam, Conduct awareness: We conducted a total of 10 "Gajah Katha" events, our signature outreach campaign. The Information Education Communications (IEC) materials of the second phase of Gajah Katha, which focussed on effective mitigation measures to reduce human-elephant conflict were used. Moreover, we conducted seven outreach events where we used both IEC materials from Gajah Katha phase I (about elephant ecology) and II to generate awareness. Through these 17 outreach events we reached out to around 553 people, of which 274 were males and 279 were females. In addition to Gajah Katha, we conducted several other outreach programmes targeting students, youths, farmers, and women to generate awareness. We conducted a total of 75 such events, reaching out to around 3499 people, of which 882 were males and 972 were females, in addition to 1645 students. On World Elephant Day, which is globally observed on 12th August, we conducted multiple events at Namoni Gazera village in Majuli district including wildlife quiz competition, creating elephant sculptures from colourful clay, nature games, and exhibitions of the handloom products of our beneficiaries. Officials from Majuli Forest Division, President and Secretary of TMPK Gazera Ancholik, member of Zila Parishad, and Gram Pradhan of Gazera attended the event.

Output 3: Protecting livelihoods and assets

Training to RRUs: Based on the training provided by our team, the RRUs have continued collecting information on elephants' presence in their vicinity and sharing the alerts in "WhatsApp groups" (DI-A04). Given the effective HEC-alert managed by the RRUs and their implications in sending early warnings, the other villages besides, the project villages have adopted a similar model (DI-A05). Currently, the RRUs are active in 58 villages (including the 20 project villages) with around 389 active members. During the reporting period, 68 alert messages were sent out in 10 RRU groups across project villages of eastern Assam and Meghalaya (Details in Annexure 2). Solar fence and Biofence installation

A total of 3.36 km of seasonal solar fence was installed in Sadiya (Tinsukia). While in Jorhat and Sivasagar districts, the project team along with the local community members is currently installing around 38 and 39 km of seasonal fence respectively. The solar fences are installed before the paddy harvesting season which begins in November.

We planned to provide 21 km of biofence (7 km in each row, with three rows is place) using Assam Lemon. During this reporting period, we planted around 3 km of biofence but lost most of the saplings to the flood. In Sadiya, we planted 1 km of biofence, and lost around 0.5 km to flood, which will be replaced with 800 lemon saplings. In Sivasagar, we lost the biofence to flood, and plan to provide additional 4800 saplings for biofence. Similarly, another 2 km of biofence was lost to flood in Majuli. Additionally, 2400 saplings will be supported for replanting.

<u>Effectiveness of the solar fences</u>: The project team has established a system to regularly monitor the solar fences and check whether the fence has been working effectively in all locations. In the project village of Sadiya, elephants broke the fence during the month of April 2024 which was repaired instantly.

Output 4: Promoting supplementary livelihoods

<u>Supplementing Livelihood-</u> In the last six months, we have supported 145 beneficiary households from 20 project villages (DI-B10). These households were selected based on preset criteria (details provided during year 1 annual report). Each beneficiary household is monitored regularly to ensure that they continue their efforts after receiving the training and earn additional income. Moreover, the beneficiaries already supported are monitored at regular intervals.

Output 5: Sharing knowledge and building capacity

<u>Joint village meeting to share findings</u>. In the last six months, we conducted 20 village meetings to discuss the project initiative and progress and receive feedback/input from the beneficiaries and other villagers. During one such village meetings, the villagers highlighted the need and use of vermicompost for better cultivated produce. Taking cognisance of this, we organised a capacity building training on vermicompost production.

In addition to this, the team made efforts to reach out to the people from the flood-affected project villages in eastern Assam and provided them with immediate relief materials such as mosquito nets/repellent, disinfectant, sanitary pads, tarpaulins, medication kits and few cooking utensils.

During June-July 2024, 10 project villages in eastern Assam districts of were affected by severe annual floods. The flood significantly affected two months in these villages.
