### Output 1:

**Regional workshops:** At least three virtual and/or in-person pre-workshop meetings were held with partners in each of the HEC regions to introduce the project and discuss partner organizations' roles and contributions. Due to differences in priorities and management, separate meetings were scheduled for Kaeng Krachan NP and Kui Buri NP. Local partner organizations have offered to help offset the additional costs of separate meetings. To ensure equitable benefits, ZSL and HEVN negotiated opportunities for collaboration and capacity-building with partners in each HEC region. Regional workshops have been scheduled from late September through December in line with partners' schedules and availability, and sometimes extended to two-day workshops with matched funds from regional partners to accommodate regional agendas and capacity needs.

**National workshop**: Given that the project introduction was conducted during pre-regional workshop virtual meetings to facilitate negotiations, the national workshop with regional project partners was rescheduled to the end of November and will consist of presenting and reviewing a summary of the data collected during the regional workshops, including participatory HEC maps and trends, capacity assessment results, and preliminary results from the systematic review.

**HEC mitigation capacity assessment:** Online HEC capacity and HEC data surveys were disseminated during pre-workshop meetings and partners have been given until the end of November to complete the surveys. Capacity surveys were also presented during the regional workshops with options to fill out an online or paper version. Different capacity survey formats were developed for community elephant guarding teams, DNP, and NGOs, tailored to the organizations' structure and experience. For example guarding team surveys focused on their experience and capacity around responding to elephant crop raiding, while DNP and NGO surveys focused on capacity to implement and monitor many HEC mitigation methods. So far, OCA surveys have been completed by 14 organizations in Khao Yai, 29 elephant guarding team members from the Eastern Forest Complex, and 40 elephant guarding team members from Dong Phaya Yen Khao Yai. Surveys will be edited as needed for clarity and replicated at the next four regional workshops in Q3. All survey data will be collated and synthesized in Q3 and Q4 to inform and develop best-practice guidelines for HEC mitigation, the systematic review, and project monitoring and evaluation. Additional baseline surveys will be designed and tailored for smallholder farmers for the insurance focus groups in 2024.

## Output 2:

**HEC insurance feasibility assessment:** IIED has been elevated as partners in the project to support and guide throughout the three years of the project. Selection of an appropriate insurance broker consultant is ongoing, but consultation with local Thai agricultural insurance experts, including Dr. Sommarat Chantarat Janvilisri, has narrowed down candidates. Focus groups with farming communities in five HEC regions to assess financial impact of HEC and WTP premiums have been scheduled for early 2024 after the regional meetings are completed.

### Output 3:

**Elephant-friendly alternative livelihoods assessment:** In Year 1's first half, Output 3's Elephant-friendly Livelihood Feasibility Assessment and Market Analysis has been a key focus, co-funded by the WWF-NbS Accelerator programme. An agroforestry consultant and a value-chain advisor have been contracted to collaborate with ZSL, HEVN and other partners in the development of value chains for HEC-friendly agroforestry commodities in the 16 sWEFCOM focus communities.

Activities 3.1, 3.2, 3.3, 3.4 and 3.5 have all been initiated, and 3.1 (soil and farm groundtruthing surveys) and 3.2 (identification of suitable elephant-friendly agroforestry/alternative crops) are slated for completion in Y1Q3 following fieldwork in November 2023. This fieldwork will include ground-truthing geospatial mapping data and conducting multi-variable land suitability tests on proposed agroforestry sites, including soil sampling and community engagement.

Qualitative and quantitative data being collected under Activities 3.3 and 3.5 will be used in the selection of agroforestry crops (Activity 3.2), as well as in the development of a financial model for agroforestry development. This will help to ensure that value-chain development undertaken under Output 3 is sustainable and in alignment with local and national objectives, with the possibility of integration into more complex agricultural financial models such as carbon crediting and agricultural insurance (Output 2, Outputs 3.2, 3.4).

## Output 4:

### Capacity building of elephant-friendly coffee CBO:

A workshop was conducted at Kanchanaburi Rajabhat University on 25 August to disseminate the coffee agroforestry NbS components of the Darwin project to stakeholders including The Thong Pha Phum Coffee Enterprise Group, Provincial Agriculture office, local farmers and coffee graders, the Kanchanaburi Provincial Commerce Office, coffee shop representatives, and the Tourism Authority of Thailand. This was also an opportunity to obtain insights and perspectives from the various actors along the value chain to ensure project success. Suggestions included ensuring alignment of government land use guidelines with those of ethnic groups, price incentives to encourage transition to coffee over other economic crops such as durian, and careful consideration of the additional effort and challenges involved in switching to coffee agroforestry to ensure quality and marketability. HEVN is regularly engaging with the TPP Coffee Enterprise Group and the local communities in TPP and is in the process of developing criteria to select households for scaling the coffee agroforestry model.

2. Give details of any notable problems or unexpected developments/lessons learnt that the project has encountered over the last 6 months. Explain what impact these could have on the project and whether the changes will affect the budget and timetable of project activities.

Pre-workshop introductions, negotiations, and scheduling with the five HEC regions have delayed the regional and national workshops, but these activities are still expected to be completed within Y1. In addition, IIED was elevated from consultant to partner and their support extended equally across all three years of the project rather than concentrated in Years 1 and 2. This process has delayed selection of an insurance broker, but should not affect activity delivery as data collection to inform the development of insurance products is ongoing and guided by the recently published "Insurance to promote human-wildlife coexistence" how-to guide co-developed with IIED and ZSL. Administrative delays in hiring an agroforestry specialist have also delayed soil and farm mapping surveys to Q3, but an agronomist has been hired and will be conducting field visits and surveys in November. These changes should not impact the project timeline, as all other activities are currently on track, and have not significantly altered the budget.
