All activities set for the first half year have been completed duly and those planned over several quarters are in progress. Indeed, at the onset of the project, three calls were made in May 2023, to recruit graduates from the University of Parakou, on a gender-equal basis to encourage both female and male to apply. The FC-SSA website and social media accounts are created for Benin and still ongoing for the rest of beneficiary countries. Five meetings were carried out on Zoom and in person in the UK and Benin for M&E, disaggregating measurables by gender while household income data will be covered in later reports.

For output 1 on conservation planning, a database has been initiated to accumulate information. Information is being accumulated about:

- > fungal diversity impact on wealth and well-being and its loss impact on poverty and gender issue (in Benin and Zimbabwe).
- > national awareness of fungi among administrators and politicians, in education and in public using media, social media, journals, and official websites (in Benin and Zimbabwe).

For the Outputs 2 and 5 about livelihoods protection and public awareness, the project leader and some graduates have Introduced the project to authorities and local communities in the project target villages in Benin and work on plans for future visits by other core staff. Agreed dates March/April 2024 on course delivery based on gender neutrally basis. A call for the course will be issued in the next quarter in four languages and will be published in Women Major Group and social media accounts (official and personal) to ensure wider outreach and gender-equal response. Between July and August 2023, flyers and stickers bearing the image of the FC-SSA Project were designed for publicity and awareness. Digital Marketing Course (National Qualification) is in progress, in preparation for publicity campaigns and data analysis. We plan to hold exhibitions in national and regional universities, at the head quarter of UNEP and at other scientific events. Also, forest inventory was carried out in community forests in the target villages in Benin from July to August 2023 to evaluate the potential of regeneration sites for receiving transplants from nurseries and for agroforestry intercropping and other restoration treatments. The same thing has been done in Zimbabwe. Introductory course in permaculture to the project leader in the UK during August-September 2023, to highlight the elements of gender equality in community participation and designs. Other courses for participants are planned for subsequent quarters. The course materials drafting is ongoing. Facilitation software and materials have been purchased.

For output 3 about poverty and gender equality issues, a review of relevant literature is in progress. Initial search using Google scholar, Academia, ResearchGate, FAO website, CABI website, UN and UN associated organisations websites.

For output 4 about infrastructure, trainings were provided and planned to continue during the next quarters, to develop expertise for graduates in fungal status assessing at national level, fungal data management, ecological restoration of damaged ecosystems, collaboration with national conservation NGOs, ethnomycological survey and literature review, software and website development. The preparation of the West Africa field guides still ongoing.

2. Give details of any notable problems or unexpected developments/lessons learnt that the project has encountered over the last 6 months. Explain what impact these could have on the project and whether the changes will affect the budget and timetable of project activities.

The main problem so far encountered in this project has been in promoting a gender balance in its activities. Despite a clear indication that women candidates were sought, only one of the graduate applicants was female, and the gender balanced interviewing panel found that, compared with the other candidates, she was too weak to be a viable option. Similar problems are being encountered in village outreach, where women are proving very reticent. Project partners recognize this and intend to explore new ways to achieve gender balance. Another problem encountered is difficulty in accessing few sacred forests. The fact that access to this type of forest is restricted by its sacred nature is a real barrier to anthropogenic threats and an effective means of protecting the biodiversity that it shelters. Dialogue with those responsible for sacred forests is continuing.
