Over the past six months, our project has made continued progress, and we are on track to complete all the activities within the project period. We appreciate the detailed feedback received from the BCF review of our annual report and have taken steps to ensure that the feedback is incorporated into the project.

Activity 3.4 and 3.5:

- We have confirmed dates for the 2024 Conservation Tools Course. The course, including the new LHPWC module, will occur face-to-face between the 8th of January and the 8th of February at a training facility in the Atlantic Forest, Brazil. We have drafted the training timetable and are beginning to update and prepare the training materials.
- We have begun discussions as a team and with ZSL's M&E specialist (to be reported in the FYR) to explore ways we might improve the feedback and evaluation methods for the course in advance of when we would normally send out pre-confidence surveys.

Activity 3.6:

- We are updating our website, scheduled for completion by December 2023. As part of these updates, we are speaking to our website developer about creating a password-protected area of the website where we can host training content. This password-

protected area will ensure that our training content remains accessible with M&E built into the learning experience.

Activity 3.7:

- We have had further discussions with the EDGE Fellows from the Asia cohort during their two-week visit to ZSL in August and September 2023 about which of their host organisations might be interested in participating in an online webinar. Discussions were positive and several indicated an interest.

Activity 4.1, 4.2, 4.4, and 4.5:

- We are continuing to support EDGE Fellows from the 2022 Asia cohort with their project delivery.
- Seven of the eight 2023 Africa EDGE Fellows have finalised their project plans, many of whom have incorporated LHPWC issues and the skills and knowledge they gained from their training into their objectives. One example is Ikechukwu Godwin Chinemerem from Nigeria, who has two such objectives expected to diversify livelihood activities, reduce poverty, and promote the enabling conditions required to improve the conservation status of EDGE amphibian species.

Activity 4.3:

 Members of the EDGE team have carried out project visits to four of the eight EDGE Fellows in the 2023 Africa cohort. These visits, conducted in Kenya and Tanzania in June, July, and August 2023, helped the EDGE Fellows to refine their project plans and initiate the implementation of their projects.
