The project started on July 1, 2022. During the first three months of project implementation, the following progress was made against the planned activities in the agreed project implementation timetable:

Output 1

1.1. Facilitate project inception meetings

CANARI completed project start-up activities, including development of the project webpage on CANARI's website, project brief as well as facilitation of inception meetings among the CANARI project team, project partner IIED and the project teams of the complementary projects also being implemented by CANARI. These projects include the Critical Ecosystem Partnership Fund (CEPF) Caribbean Islands Phase II investment (CEPFII), the sub-project under the Global Environment Facility (GEF) Integrating Water, Land and Ecosystems Management in Caribbean Small Island Developing States (SIDS), and the Inter-American Development Bank (IDB) Lab supported 'Experience Nariva' project.

1.2. Conduct consultations with Haitian CSOs to identify needs and potential fellows

Work on this activity began but was not completed during Yr1 Q2. Under the complementary CEPFII project that CANARI is also implementing, a Haitian Country Coordinator was recruited during Q2 to prepare a list of civil society organisations (CSOs), including community-based organisations active in the CEPF priority Key Biodiversity Areas (KBAs) in Haiti, including descriptions of the CSOs and current activities in the KBAs. The Haitian Country Coordinator will also be conducting a technical and organisational capacity needs assessment of the

identified Haitian CSOs – this work will be carried out in Q3. Once this work is initiated, CANARI will be able to identify needs of selected Haitian CSOs and potential fellows.

2. Give details of any notable problems or unexpected developments/lessons learnt that the project has encountered over the last 6 months. Explain what impact these could have on the project and whether the changes will affect the budget and timetable of project activities.

The political and social unrest in Haiti was identified as a major risk (Risk 4) in project development and unfortunately, the situation has worsened. Due to this situation and the adverse impacts on safety and security, CEPF has not yet been able to operate in Haiti and is currently assessing the viability of doing so as grant-making activities there are dependent on express permission from the World Bank (as the funder of the CEPF Caribbean Phase II investment) and Conservation International (as the secretariat for the CEPF). As a precursor to initiating grant-making in Haiti, CANARI as the Regional Implementation Team (RIT) for the CEPFII project is currently conducting a situational analysis of conservation actions in the CEPF priority KBAs in Haiti and reaching out to prospective grantees to build their capacity to apply to CEPF for small and large grants. This work is being carried out by CANARI's Haiti Country Coordinator.

This DARCC015 project was developed with the assumption that CEPF would award at least six grants to Haitian CSOs working in and around priority Haitian KBAs. It was intended that the fellows who would participate in this DARCC015 project would be selected from these CSOs. CANARI will have more information in the next quarter in terms of if CEPF can proceed with grant-making in Haiti or not. CANARI still believes it is possible for this project to engage six fellows based on the research that the Haiti Country Coordinator is carrying out, however, there may be a slight delay. CANARI does not see the need to request changes to the budget at this time.
