Four activities were planned for Q1-Q2 FY 2024-2025

- 3.2.1. Support and mentor Implementers, virtually or with site visits, to overcome political and technical implementation challenges

- **2.4.3. Support network participants in their peer- learning process:** As well as generally supporting our Bolivian trainees in the field, in October a team of 12 Bolivian trainees and staff from Natura visited Cali to meet with their Colombian counterparts and exchange lessons and experiences. They visited one of the first Colombian RWA, in the indigenous communities of Resguardo Indígena Betania and Triunfo Cristal Páez, which was particularly interesting for the indigenous Bolivians from San Ignacio and Charagua.
- 3.1.1. Mentor the workshop participants ("Implementers") who will be setting up Reciprocal Watershed Agreements around their Key Biodiversity Areas: In June we held a third training workshop, this time in Peru, in the municipality of Oxapampa, close to the Asháninka-Yánesha Biosphere Reserve KBA. This workshop, led by partner Instituto Bien Comun (IBC), focused on building the capacity of new "JASS" to enter the RWA program. JASS are rural water boards, in some cases very small, ranging from 50 to 200 families, they do not have water consumption meters, and are community-based organizations. Eight new JASS participated in the three-day workshop (we had invited 13 JASS), and in attendance were Municipal Technicians, the national water regulator (SUNASS), and a representative of the biosphere reserve for a total of 26 participants. Conclusions were that the JASS can legally include an additional contribution for conservation, and that they will start to promote the RWA mechanism to their water users, along with the Municipal Technicians. All eight of the participating JASS agreed to implement RWA, under a work plan that they will prepare with the technical support of IBC.
- **3.1.2.** Assist implementers in incorporating Conservation Agreements into annual operational planning: After the school, we met with the mayors of Chontabamba and Oxapampa who asserted that both their municipalities will be able to co-finance the RWAs that are to be executed bby IBC. Moreover, both municipalities have the facility to establish a municipal Water Fund, and the Management of the Biosphere Reserve also wishes be part of each Fund as an operating entity. Indeed, the deputy manager of the Biosphere Reserve, Julio César Castillo, noted that the coordination committee of the Reserve more than 15 organizations wants to act as the primary program operator and can actually help finance RWA implementation. Interestingly, just as in Bolivia, the Biosphere Reserve managers consider RWA as one of the main strategic lines for the conservation of the area. We also held meetings were with the municipal technicians who monitor water quality and the operation of the systems, who will be part of the operations team. Meanwhile, the SUNASS representative Jesús Flores, committed to trying to access co-finance from the District of Oxapampa.
- **3.2.1.** Support and mentor implementers, virtually or with site visits, to overcome political and technical implementation challenges: There literally thousands of RWA in Bolivia, across a variety of ecosystems, but all related to maintenance of water quality. The Colombian partner, the Corporación Autonoma Valle de Cauca (CVC) invited program partners to visit a brand-new type of RWA, in the mangroves to the south of Cali. Twelve Bolivian partners spent two days with CVC in the community of Punta Bonita, learning how the same RWA principles used in the dry Chaco forests are being applied by afro-Colombian women and children to protect mangroves and the piangua shellfish, vital for the local economy (see this link for a description of the visit https://youtube.com/watch?v=eCT6k3JaToU&feature=shared).

We will hold the final workshop of the project in Ecuador in Q4 and are meanwhile continuing with all capacity- and network- building activities. We consider that the project is advancing well, and that our indicators are still relevant, and our assumptions still hold true.
