Central Asia is home to a wide range of species listed in CITES, many of which are traded internationally. These include Saker falcons, Central Asian tortoises, Saiga antelopes, medicinal plants Cistanche deserticola and spring Adonis[2]. Unsustainable and illegal trade in these species threatens the survival of species and their fragile ecosystems, and endanger the livelihoods of people that rely on use and trade for their livelihoods. Despite this rich biodiversity, Central Asia's representation in CITES decision-making processes and expertise on CITES-related issues remains limited[1].

In the first-of-its-kind 2024 report[1], TRAFFIC established the baseline of wildlife trade in Central Asia, emphasizing how fundamental this issue is for conservation and poverty alleviation. The gaps to implement effective responses to unsustainable use and trade challenges were also assessed – most critical were capacities of national stakeholders – to develop and enforce appropriate responses to wildlife trade and trafficking, confirmed at the recent Central Asia wildlife trade workshop at the IUCN Regional Conservation Forum[6].

An upcoming milestone for the region is the CITES Conference of the Parties (CoP20), scheduled to be held in Uzbekistan, December 2025. It presents a critical opportunity to strengthen Central Asia's capacity to engage in global wildlife trade discussions. By building expertise in wildlife trade regulation and sustainable use, stakeholders in the region will be better equipped to contribute meaningfully to these discussions and influence outcomes affecting biodiversity and local communities.

Kyrgyzstan faces distinct challenges as a major transit hub for wildlife trade. Poaching of species like snow leopards and domestic demand for wild fauna and flora in traditional medicine threaten biodiversity. Compared to neighbouring countries, Kyrgyzstan's limited monitoring and cross-border smuggling create unique conservation issues[2].

Over 40% of the Central Asian population lives below the poverty line, and sustainable wildlife use, when properly managed, has the potential to alleviate poverty. However, concerns have been raised about selective harvesting practices, such as a reported decline in the size of Argali sheep trophies in Kyrgyzstan. Addressing this requires better understanding and transparency in developing NDFs and CITES permit approval.

TRAFFIC, developed a 9-step NDF Guidance [5], adopted by CITES Parties at CoP19. An NDF workshop for CITES authorities was held in Kenya last year, however, no representatives from Central Asia attended. The guidance is currently being updated and finalized, offering an opportunity for Central Asia to strengthen its expertise on NDFs and to connect to communities developing a harvesting permit.

This project aims to strengthen the capacities and capabilities of national CITES authorities of Kyrgyzstan, Kazakhstan, Tajikistan, and Uzbekistan, civil society organisations (CSOs), media and academia in Kyrgyzstan, and TRAFFIC in Central Asia to implement effective wildlife trade interventions and promote sustainable use. Local community engagement will be supported, building on recommendations from the Chunkurchak Declaration from the IUCN Sustainable Use and Livelihoods Conference in Central Asia[4], and the long-term goal is to achieve significant conservation outcomes through the empowerment of local communities and poverty alleviation.

Convention on Biological Diversity (CBD): especially Targets 5 and 9, on the legal, sustainable and safe harvest, use and trade of wild species, and benefits to local communities occurring from sustainable use. Project supports national stakeholders to contribute to the updates and reporting under National Biodiversity Strategies and Action Plans (NBSAPs).

CITES: enhance national and regional Central Asia capacity to monitor wildlife trade, ensure that NDFs are based on sound science, and streamline the permitting process for CITES species. This project will also foster regional cooperation, which is vital for controlling cross-border wildlife trade and harmonizing enforcement measures.

Convention on Migratory Species (CMS): Many Central Asian species that are protected under CITES are also covered under CMS, and wildlife-trade-related capacity and capability development at national and regional levels will contribute to CMS national commitments of ensuring the conservation and sustainable use of migratory species.

UNFCCC: Protecting biodiversity from overexploitation plays a crucial role in ecosystem resilience and climate adaptation, in particular in sensitive ecosystems in Central Asia, including through national stakeholders capabilities to contribution to NDCs and NAPs, via the link to conserving species and sustainable wildlife management

Sustainable Development Goals (SDGs): SDG 15 (Life on Land): support halting biodiversity loss and preventing the extinction of threatened species. SDG 12 (Responsible Consumption and Production): contribute to reducing illegal and unsustainable wildlife trade, promoting more sustainable consumption of natural resources. SDG 13 (Climate Action): contribute to climate mitigation and adaptation strategies.

Strengthened capacities and capabilities of national and local government and civil society stakeholders in Central Asia will provide contributions to a range of relevant regional initiatives, including the Central Asian Mammals Initiative (CAMI), Green Central Asia Initiative (climate and environmental cooperation), and the Saiga Conservation Alliance.

The project will deliver the Outcome through a set of linked activities under three outputs.

Output 1 focusses on strengthened knowledge and capacity of Central Asian CITES Scientific and Management Authorities (SA and MA) to regulate trade in wild species and contribute to alleviating poverty of local communities.

We will focus on the capacity of four Central Asian CITES SA and MA, to develop strategies for implementing the CITES, with focus on the sustainable use of species listed in Appendix II. TRAFFIC will conduct a three-day workshop in Kyrgyzstan (co-ordinated with project partner, Kyrgyz CITES MA), with identified representatives from Kyrgyzstan, Uzbekistan, Kazakhstan, and Tajikistan. This workshop will help prepare national agencies to engage in CITES CoP20 in Uzbekistan, focusing on how to navigate the CoP, key agenda items, and develop evidence-based recommendations.

The workshop will cover CITES permitting processes, including non-detriment findings (NDFs), determining permit validity, and compliance with CITES reporting requirements. We will involve local community representatives in the workshop, to improve NDF requirements understanding before applying for a harvesting permit. The participants will be guided on how to correctly complete permit applications.

Training materials will be identified and developed (adapting to country-needs), translated into Russian, supporting regional knowledge sharing and collaboration. The materials will be tested to ensure their suitability and effectiveness. Addressing the likely staff turn-over, we will focus on ensuring the continuity of the capacity-building by making materials available in the long-term and seeking government agencies' commitments to future trainings.

The project will host a side event at CITES CoP20 in Uzbekistan, to raise awareness about wildlife trade priorities in the region, putting national and local stakeholders to the fore-front, and fostering collaboration. It will serve as a venue to showcase the positive impacts on communities and Central Asian species from legal and sustainable trade, including the representation from local community members. We will reach out to CITES agencies, and donors, to co-host the event.

Post-CITES CoP, TRAFFIC will draft and engage with stakeholders regionally to collate lessons learnt and recommendations report to focus on regional follow-up actions and priorities to implement the Decisions.

Output 2 will contribute to the increased capacities in managing wildlife use and trade and knowledge sharing among civil society organisations, researchers and media in Kyrgyzstan, and regionally.

TRAFFIC will coordinate two workshops with NGOs, journalists and academics, to discuss sustainable use issues relevant to Kyrgyzstan. Firstly, a two-day workshop to develop strategy and assess the needs, followed by a three-day tailored training workshop based on feedback and recommendations. Anticipating that resourcing of activities is an obstacle, the project will seek expert advice on funding and donor priorities on wildlife trade issues, feeding findings into the second workshop.

These interactions will create a platform focused on knowledge sharing and capacity of stakeholders in Kyrgyzstan, on wildlife trade, conservation, and sustainable use. The Partnership Platform will involve NGOs working on wildlife protection and community empowerment issues, such as Bugu Ene Zoopark, Fauna & Flora, Camp Ala-Too, Ilbirs Foundation and the Kyrgyzstan Association of Protecting Wildlife, academic representatives and journalists. This platform will have continuous exchange (via agreed communication channel), rotation of hosted meetings and webinars. The platform will include at least 50% of women.

Utilizing the presently not operational IUCN SULi Central Asia group, we will expand and activate the mailing list to foster exchanges between relevant stakeholders across the region.

Under Output 3, TRAFFIC in Central Asia will be supported as a capable wildlife trade and CITES resource in Central Asia.

TRAFFIC has a project team in Central Asia with expertise in wildlife trade and CITES matters. Under this project, our team capacity will be strengthened, and we assess potential hosting or similar arrangements for a more permanent presence to support biodiversity conservation and poverty alleviation in this crucial region and have a strategy for long-term resourcing.

In order to provide ongoing support to the CITES Authorities in the region, we will organize meetings in four target countries after CoP20 to discuss country-specific wildlife trade issues and to support project countries in the run up to the 2026 Standing Committee meeting (SC80). TRAFFIC will attend SC80 to provide on the ground support to project countries and to assist all Central Asia CITES Authorities (e.g. including Turkmenistan).

TRAFFIC will also produce the bi-annual CITES Newsletter in Russian and English[6], highlighting news related to CITES in Central Asia and on CITES-listed Central Asian species abroad, to raise awareness and provide on-going knowledge-sharing to stakeholders and public about wildlife trade issues

Q16. How will you identify participants?

How did/will you identify and select the participants (individuals and/or organisations) to directly benefit from the <u>capability and capacity building activities</u>? TRAFFIC will build on existing relationships with government agencies in target countries to confirm participants at the implementor level to attend trainings. Where some countries have multiple MAs or SAs, we will collaborate with the project countries to identify the most relevant staff. The focal points are:

Kazakhstan: Ministry of Ecology, Geology and Natural Resources (MA), Ministry of Education and Science (SA:animals-not fish) and Ministry of Education and Science of (SA:plants). While Kazakhstan is an Upper Middle-Income Country, it is essential to include due to regional overlap in crucial CITES and biodiversity conservation interventions.

Kyrgyzstan: Ministry of Natural Resources, Ecology and Technical Supervision (MA and project partner, see Letter of Support), Institute of Biology of the National Academy of Sciences (SA).

Tajikistan: Committee of Environmental Protection (MA), National Center for Biodiversity and Biosafety (SA).

Uzbekistan: Ministry of Ecology, Environmental Protection and Climate Change (MA), Institute of Zoology under Academy of Sciences (SA).

We will engage our the network of existing contacts – including IUCN SULi – to identify local community representatives to join trainings and CoP20.

Target CSOs in Kyrgyzstan are those committed to collaboration and supporting biodiversity conservation and poverty alleviation, and have wildlife use and trade issues within their organisational mandate. Workshop and Partnership Platform participants will be active decision-makers in their organizations, ensuring they can implement changes and provide training to enhance learning and capacity within their organisations. These are likely to include Bugu Ene Zoopark, Fauna & Flora, Camp Ala-Too, Ilbirs Foundation and the Kyrgyzstan

Association of Protecting Wildlife. We will approach a broad range of media and academia representatives to join the capacity-building events and the Partnership Platform.

GESI considerations will be incorporated in all stages from identification of workshop participants to providing ongoing support.

In TRAFFIC's 2030 Strategy and policies, gender and social inclusion plays a crucial role in how TRAFFIC conceptualizes, implements and monitors its activities. TRAFFIC will engage in gender situational awareness mapping for select activities and further research, including gender and social dimensions. These will inform activity development, the robustness and granularity of tools, platforms and reporting functions, and MEL framework with indicators disaggregated by gender. TRAFFIC will ensure that these aspects are consistent and standard across all project partners.

Recognizing that across our target countries many of the projects target sectors are historically male dominated, TRAFFIC will, where possible, prioritise female participation at meetings, training workshops and other project-related activities to ensure that women have a voice in influencing project outcomes. The selection criteria for participants will ensure there is appropriate representation and will be completed in partnership with the relevant authorities.

TRAFFIC respects diversity and adheres to the IUCN Code of Conduct and Professional Ethics which provide guidance about the standards of ethical conduct. Principles include Equality, inclusiveness and respect for the diversity of people. Beyond the disaggregation of gendered data and efforts to facilitate the participation of women in the project's research activities, efforts shall be made to explore the specific relevance of gender in biodiversity conservation and poverty alleviation. Women are often responsible for particular roles both in legal and illegal wildlife trade. This gendered dimension of IWT, and efforts to combat the crime, is often ignored and under-researched, leading to imperfect interventions which fall short of delivering holistic impact. A gender-sensitive approach will be taken in designing research, and content of training and support materials. Where feasible, we will include gender-disaggregated data in the assessment of project results.

Our theory of change is as follows: If we empower Central Asian national CITES Scientific Authorities to create scientifically robust Non-Detriment Findings, and equip CITES Management Authorities to issue legally sound permits; enhance collaboration and knowledge sharing among CITES Authorities, CSOs, media and research organisations on CITES-related issues and biodiversity conservation; and ensure TRAFFIC in Central Asia as a capable resource on CITES and wildlife trade issues to foster ongoing collaboration and learning beyond the

project's life; then we can promote biodiversity conservation and poverty alleviation by enabling the sustainable and legal trade of Central Asian CITES-listed species.

In the short term:

- Project empower at least two Central Asian CITES Authorities per country to have a stronger voice in the CITES arena, at CITES CoP20. By strengthening the expertise of at least two CITES Authorities from each project country (Management Authority and Scientific Authority), with a goal of 50% gender balance—we aim to enhance their capacity to engage in global wildlife trade discussions. This will help regional stakeholders contribute more effectively to shaping outcomes that benefit both biodiversity and local communities.
- -The Partnership Platform will engage and empower at least 12 representatives from at least 10 key Kyrgyz CSOs, media and academia, to support biodiversity conservation and poverty alleviation, aiming for 50% gender balance. This platform will create a new space for civil society organisations in Kyrgyzstan to discuss issues related to wildlife trade and find areas of commonality for future collaboration and fundraising efforts.
- The funding opportunities review and support resources to local organisations in Kyrgyzstan, and through the IUCN SULi Central Asia sub-group (re-engaged by the project) will lead to increased visibility and resources to deliver interventions addressing trade and use priorities in the region.
- -The CITES Newsletter, published in Russian and English languages, will continue to raise awareness among stakeholders and the public and provide on-going education on legality of CITES-listed species in Central Asia to reduce instances of illegal trade.
- After CoP20, TRAFFIC staff will meet with Central Asian Authorities to address country-specific wildlife trade issues, provide on-the-ground support, and build lasting relationships with regional CITES Authorities.
- The project training materials tailored for national CITES agencies and CSOs/media/academia will be made available beyond the project end.

In the long term

- The issue of wildlife trade and use of wild species is widely recognised as a priority for action and funding in Central Asian region, with national and local stakeholders capable of developing and delivering effective interventions.
- By following up in meeting recommendations from the SULi conference in Central Asia, this project will achieve conservation through community empowerment and poverty alleviation by documenting wildlife practices, building capacity for government and local organizations, and supporting stakeholder dialogue. This includes promoting sustainable livelihoods based on wild resource use, ensuring communities benefit from conservation efforts while protecting biodiversity and strengthening local resilience.

Q19. Sustainable benefits and scaling potential

How will the project reach a point where the benefits of strengthened capability and capacity can be sustained post-funding?

How will the capability and capacity be retained and remain available to deliver benefits in-country after the project? Is there potential for the new capability and capacity to renew itself or deliver additional capability and capacity, for example by building future environmental leaders beyond the project?

Our objective is to empower CITES Authorities and CSOs to enhance their capabilities for biodiversity conservation and poverty alleviation through strengthening their CITES implementation and CITES meeting participation.

To ensure the sustainability of the project, regional engagement will be prioritized throughout the project and materials will be accessible in local languages. A key challenge currently is the exclusion of Central Asian stakeholders from global conservation dialogues, and the lack of focus on biodiversity in national agendas, which hinders awareness and participation. To address these gaps, TRAFFIC will coordinate efforts to engage local stakeholders by organizing pre- and post-CITES CoP meetings and workshops, ensuring they are well-informed about CITES processes and decision-making. Additionally, translating CITES tools and documents into Russian will facilitate greater understanding among key government and CSO representatives, enabling their continued involvement in conservation efforts even after the project's initial funding ends. TRAFFIC staff's own capacity will be built through the project and strategic missions to visit government stakeholders in the project countries built into the project planning, to promote collaboration and sustained dialog.

As part of Activity 2.2, we will foster networking among CSOs in Kyrgyzstan by establishing a Partnership Platform, designed to create a sustainable peer-to-peer support mechanism that extends beyond the project's lifespan. By facilitating new connections and relationships across the sector, we expect long-term impact through continuous collaborations, offering CSOs opportunities to grow by working together. This Platform will serve as a bridge for ongoing strategic peer networks, enabling participant CSOs to support each other sustainably into the future.

Our local TRAFFIC staff will maintain close connections with and provide ongoing guidance to the CSOs and CITES Authorities and will search for funding to continue to publish the bi-annual CITES Newsletter beyond the lifespan of the project.

The team will maintain regular communication via electronic means, hold monthly meetings to review progress and address challenges, and conduct quarterly internal evaluations based on monthly reports from the Project Lead and the M&E Project Officer. It will also develop plans to adjust the project's direction and implementation as necessary.

Project staff will continuously engage in monitoring and evaluation (M&E) to ensure the project remains on track to meet its indicators, assess both positive and negative impacts, and make any necessary adjustments as needed. The Project Officer, under the supervision of the Project Lead, will hold bi-weekly calls with the Project Lead to share updates on recent progress and challenges.

This project is new, with some activities aligned to TRAFFIC's ongoing projects, which will match funding, including the continuation of the regional CITES Newsletter, which started under the US government INL funded project. In our work to date, including through the Fauna & Flora-led Illegal Wildlife Trade Challenge Fund project (IWT089), we have established strong network of contacts with government agencies in the target countries, and civil society organisations, and will build on these in the proposed work.

In Kyrgyzstan, the Ilbirs Foundation had been delivering capacity building trainings, but mostly to individual hunters, and this proposed activity will focus on different stakeholder groups. Fauna & Flora has been an important partner of TRAFFIC in Central Asia to date, and implements projects, including on conservation

capacities and capabilities in Tajikistan. We will continue collaborating on the proposed focused wildlife trade and sustainable use capacity development, including through the Partnership Platform.

Q26b. Are you aware of any current or future plans for work in the geographic/thematic area to the proposed project?

A number of non-governmental organisations in the Central Asia region deliver essential conservation work, which is not disconnected from the proposed activities. For example, the Ilbirs Foundation and Fauna & Flora implement an active project, focussed significantly on the empowerment of local communities in the region. Our proposed project focuses on capacity and capability of the national-level agencies responsible for regulating and implementing/enforcing wildlife trade measures – connected at the regional Central Asia level. We also support wildlife trade and sustainable use capacities and knowledge exchange between civil society organisations, media and academia in Kyrgyzstan. To our knowledge no similar or duplicating work is taking place.

Q27. Value for Money

Please demonstrate why your project is good value for money in terms of impact and cost-effectiveness of each pound spend (economy, efficiency, effectiveness and equity). Why is it the best feasible project for the amount of money to be spent?

This project will bring value for money by centralizing CITES Authorities for pre-COP training, followed by leveraging the COP itself for networking and collaboration. Regional trainings have proven to be more impactful and cost-effective. To further minimize expenses, follow-up activities between TRAFFIC and CITES Authorities will involve a single TRAFFIC staff member traveling to the project countries for additional training and partner meetings. This approach allows for broader capacity building while reducing travel and workshop costs for multiple participants.

Additionally, establishing a Partnership Platform will enhance the project by bringing together CSOs with a shared mission. While two workshops will be organized, the Platform will become a self-sustaining resource through listservs and informal meetings.

Through creating resources on funding opportunities for wildlife trade and use interventions, local organisations will be supported to apply to varied donor opportunities, creating longer-term sustainable financing for activities.

The bi-annual newsletter will further amplify the project's impact by reaching a wider audience, raising awareness of biodiversity conservation and CITES regulations.
