



Plan International (PI) recognises that the consequences of climate change, the risks of environmental degradation and loss of biodiversity have disproportionate impacts on children, particularly girls, and especially those from the most vulnerable, poorest communities. They often have limited access to resources, skills and information to cope.

Through the Future Plan Fund programme PI UK, who will be giving direct support to this proposal, has led

the delivery of projects across Timor Leste, Kenya and Colombia in coordination with local partners, supporting sustainable coastal initiatives to empower local communities to conserve and sustainable manage their resources without risking their future sustenance.

Across these countries, PI has successfully developed a triple crisis approach to bring together actions that seek to address climate, nature and poverty issues at the local level, which is currently been replicated in other contexts.

In rural communities of Paucartambo, Cusco, Peru a 1-year collaborative research focused on identifying and proposing solutions to negative climate change coping mechanisms affecting girls and adolescent women in rural areas is taking place.

PI presence in Loreto region capital, Iquitos, focuses in long-term development projects who tackle teen pregnancy and promote youth economic empowerment, guaranteeing strong relations with CSO's and government stakeholders.

Details of anticipated roles and responsibilities:	DAR will be the implementing partner for the development and biodiversity conservation activities in the Allpahuayo Mishana National Reserve.	

Expertise in sustainable use or conservation of biodiversity and/or development:

DAR has implemented projects related to the theme of the call, it has executed technical assistance and financing for the management of non-timber natural resources and the strengthening of productive chains in the area of the Chayu Nain Communal Reserve. In Ucayali it has been implementing the IKI project on community forest management to improve the management of forest resources with the communities, working in conjunction with the regional government of Ucayali and local indigenous organizations. Work with the local communities of protected natural areas in the Loreto region for the implementation of renewable energy in public spaces that contribute to the well-being of the population was implemented. DAR participates in spaces for the construction of public environmental policies, supporting the competent authorities in the elaboration of proposals to improve public policies, such as the new NDC measure for the improvement of road infrastructure management to reduce deforestation.

For this, DAR has a multidisciplinary team with experience working in multi-stakeholder co-creation processes and a continuous working relationship with communities, especially with indigenous peoples in the Amazon. This experience and prior learning allows us to affirm that we have the necessary skills and experience to implement the project.

Q10. Justification of need for a Partnership Project

Please provide written details of why alternative funding is not available from within your own organisation or from other sources. Will matched funding be provided?

Plan International UK – in support of Plan Peru – can potentially provide sources of income, both restricted or discretionary, to submissions to institutional donors or on occasion provide stand-alone funding for projects from non-institutional donors. However, Plan International UK is currently not in a position to provide alternative funding for this due to unreserved and unrestricted funds currently being committed to COVID 19 programming. We do not currently have a donor that can underwrite this proposed project. For matched funding to be considered for the Main Darwin Initiative, the project will need to go through a review based on current funding situation at time of application.

But, Plan PE and DAR in this round will cover the expenses generated by the necessary support personnel, posts such as: logistics specialist, administrative specialist, grants specialist, etc. These will be covered by the organization to guarantee the appropriate implementation processes.

The project area is the Allpahuayo Mishana Natural Reserve (RNAM), an hour drive from Iquitos - the biggest city in Peruvian amazon. RNAM protects one of the last peatland areas and includes rainforests on white sandy soils, one of the few remaining with that characteristic. RNAM has a high number of endemic and endangered species and covers the basin head of the Nanay river, which supplies safe water to Iquitos. Regional recent climatic fluctuations have impacted wildlife and agricultural crop production, greatly affecting the local ecology and the livelihoods of inhabitants .

RNAM is home to 10 indigenous communities, with tensions between urban Iquitos populations due to uneven power dynamics. Exploitation of natural resources, lack of clarity in the limits of the conservation area and a limited flow of information reinforce these. Traditional products made in the RNAM are sold in Iquitos however, the indigenous communities require support and training to improve financial and environmental sustainability of these. Legislation application is limited, economic activities happen with no enforcement by government. Indicators of early marriage, illegal commerce, school drop-out and forced community migration create high risks for indigenous populations.

Plan International works in the Iquitos area with gender transformative projects aiming to reduce teen pregnancy and create sustainable youth economic empowerment opportunities. DAR works in the area promoting biodiversity conservation and strengthening the environmental governance of indigenous communities, mainly in rural areas, working closely with local environment authorities.

Activities will centre around a week-long workshop in Iquitos, with visits to the intervention area, attended by Plan UK (virtually), Plan Peru and DAR staff. The main objective is to exchange knowledge, experiences and share methodologies from both organizations. Plan Peru will share their gender assessment tools, child and youth centred approaches, safeguarding systems, and gender transformative training. DAR will provide training on strengthening environmental sustainability in economic activities, working with indigenous communities and conservation measures.

Together both organisations will design data collection tools that will be implemented during visits to 5 of the indigenous communities (due to time constraints) and local environmental agencies (Ministry of environment, Indigenous Communities authority, Water Management authority). Teams will gather data in intervention areas to inform the project design, this will be carried out by a consultancy team with support from both organisations. The data collected will be used to identify key elements for designing a more

robust project, which tackles specific needs, engages communities, key actors and clearly focuses on national or international treaties it aims to strengthen.

Through a strong partnership we are proposing an integrated approach to jointly tackle the triple emergency - nature loss, climate change risks, and poverty and inequality. Through our experience we have found that approaching the triple emergency together rather than as individual threats will lead to better impacts. With Plan Peru and DAR learning from each other and building a partnership together with a collaboration of our applied methodologies and processes we could create a unique partnership with a strong holistic proposal that will benefit target populations.

Our proposed outcome is to strengthen indigenous-led biodiversity conservation and sustainable management of natural resources through promoting climate resilient livelihoods. We will specifically be targeting the indigenous communities of the RNAM, whilst conducting advocacy with Iquitos urban populations to minimise the impact of tensions.

The proposed interventions aim to halt the loss of biodiversity and preserve the rich tropical peatlands, which act as significant carbon stores. The interventions will combine sustainable management of natural resource strategies whilst promoting gender transformative and climate resilient economic opportunities. The project will seek to minimise environmental harm caused by indigenous livelihood activities, and the reinforcement of underdevelopment and poverty through the existing urban/rural divide.

Key outputs:

- Enhancing skills to ensure financial and environmental sustainability of economic activities which include craftsmanship, harvesting of natural products and/or eco-tourism within communities, whilst ensuring sustainable management of the natural resources they use.
- CBO's and local authorities are trained and equipped with tools engage in trading, in an inclusive approach, to strengthen the economic activities in a sustainable manner.
- RNAM's Indigenous Communities will be linked with trade networks based in the city of Iquitos, to actively participate and ensure the sustainable distribution of their products.
- Advocating with youth community groups in Iquitos, who engage with Indigenous communities in commerce, marketing, tourism etc. to promote more environmentally sustainable practices that contribute to conservation efforts.

The project will contribute to international treaties including the Aichi Biodiversity targets and goals for Peru, which are part of the Convention of Biological Diversity. The project has an integrated approach that is framed by this convention, the Sustainable Development Goals; 7, 13 and 15, and the UN Framework Convention on Climate Change.

Using our networks of conservation and development actors, this partnership will share information on the objectives of this project with Amazon environmental and government authorities and other civil society

actors. We will be sharing learnings via publications and learning forums, so that it can be disseminated to other areas of the Amazon where it is assumed that these issues are also pertinent. We will explore themes around interdependence of rural-urban areas, exploitation of biodiversity without sustainability approach and traditional gender norms, and intend to challenge and model good practice for future programming.

Plan International Peru will be the Lead Organisation for the Partnership Project stage, under the Main Darwin Initiative Plan International UK will lead the contractual arrangements to support institutional compliance and provide global best practice. DAR and Plan International staff who participate in the Partnership Project will have an active role in the Main Darwin Initiative. DAR staff based in Loreto will utilise their extensive contacts and experience with environmental authorities in the region to support project implementation. Plan International will lead on providing a gender transformative lens with safeguarding and protection sensitive processes in the interactions with communities, ensuring technical quality and gender transformative activities in a safe environment for the entire project design and implementation.
