1. Outline progress over the last 6 months (April – Sept) against the agreed baseline timetable for the project (if your project has started less than 6 months ago, please report on the period since start up to end September).

At the time of writing, all of the team are on fieldwork around South Georgia, the South Sandwich Islands and the Antarctic Peninsula, so camera deployments and updates will follow at the end of the field season.

Since the first year report, we have launched the Penguin Watch website on the Zooniverse platform (<a href="www.penguinwatch.org">www.penguinwatch.org</a>). This received 120,000 unique visits in the first week, and at the time of writing had resulted in 540,000 images counted since launch. Due to the redundancy of effort (each image is classified by up to 20 individuals and the results clustered), this represents 20% of the total we anticipate. We estimate the classification of all 200,000 images collected until now to be classified by March 2015. This has received media attention in the press and in the international media

Meanwhile, we have joined expeditions to South Georgia, the South Sandwich Islands and the Antarctic Peninsula. This year, we are expanding the network to close to its desired maximum. We will deploy approximately 20 cameras on penguins and shags around South Georgia as well as the trial sound recorders which will be used to monitor birds that do not have visible nests. By the end of this season we will have exceeded our stated aims for the number of monitored sites around the Southern Ocean. We are also helping to set up similar projects on Ascension Island, Tristan da Cunha and St Helena.

The prototype satellite cameras deployed on the Yalour Islands have survived their first winter, demonstrating that the system works and that the power requirement calculations were sufficient. While mass production of the satellite camera units has been slow, these are now being delivered, so we will aim to place these on the remotest colonies in the South Sandwich Islands, Elephant Island and the South Shetland Islands in 2015/2016 to ensure that a real time network of cameras can report at times of years when the krill fishery is operating.

The launch of <a href="www.penguinwatch.org">www.penguinwatch.org</a> was delayed, but has now been a success and is catching up with the projected timescale.
