1. Outline progress over the last 6 months (April – September) against the agreed baseline timetable for the project (if your project has started less than 6 months ago, please report on the period since start up) (max 500 words).

The project was originally due to end at the end of July 2015, but we were granted a five month no-cost extension, to the end of November, to provide more time for the targeting and collecting of seeds over the course of the summer.

In the 6 months April to Septmber 2015, collecting has continued in all five partner countries (Output 2). For example, in Montserrat, reconnaissance visits to the field by Department of Environment staff have yielded localities for 17 target species, and seed collections made for 13 of these, all of them previously identified as priorities for the project. In the British Virgin Islands, the National Parks Trust have been collecting across the islands, with important collections of three very important target species: *Leptocereus quadricostatus*, *Erythrina eggersii*, and *Sabal causiarum*, all of which are endemic to the Puerto Rican Bank and are therefore high priorities for *ex-situ* conservation. Partners at the Department of Environment in Cayman have secured collections of 15 species in this time, with a large proportion of these from priority species.

Repatriation of seeds (Output 1): Import permits have now been issued for repatriation of seeds to Cayman and the British Virgin Islands; with shipping to Cayman, BVI and Montserrat due to take place in the last week of October. Repatriation of seeds to Turks and Caicos continues to be delayed by difficulties in purchasing a freezer for housing seeds in-country. We continue to seek progress on this matter.

A very dry summer in the Caribbean, especially in the Turks and Caicos Islands, British Virgin Islands and Anguilla, has resulted in a lower than usual level of flowering and fruiting plants in the region, making targeting species for seed collecting much more difficult. Where target species are found to be fruiting, the availability of seeds is often found to be lower than ideal. This is having an impact on achieving the target number of collections. The figure currently stands at about 216, versus the target of 250. We will continue to monitor this in the final months of the project and ensure efforts to make collections continues to the end of the project.
