1. Outline progress over the last 6 months (April – Sept) against the agreed project implementation timetable (if your project has started less than 6 months ago, please report on the period since start up to end September).

We have made good progress in the last six months. We completed the habitat models for wandering albatrosses from Bird Island and Prion Island and showed there to be marked intercolony variation in their at-sea distributions (Output 1). We also mapped and quantified the overlap between wandering albatrosses and different fisheries during the breeding season and identified high risk areas where bycatch may be of particular concern (Output 2). We presented the results of these at the 15th International Seabird Group conference in August and are currently writing up a manuscript for submission to a high-impact peer-reviewed journal.

We are currently planning our second field season, and have organised logistics, permits and equipment. The project Co-I will travel to South Georgia in early December to retrieve the tracking devices deployed last year to collect data on distribution and activity patterns during the nonbreeding season, and to deploy more devices. Specifically, we will retrieve the geolocators from wandering albatrosses breeding on Prion Island, and from white-chinned petrels breeding on Cooper Island. The geolocators deployed on these two species at Bird Island will be recovered by the field assistants who are based there. New tracking devices will be deployed on white-chinned petrels and the two species of giant petrels breeding at King Edward Point and Bird Island, to track their at-sea distributions and activity patterns during the breeding season for further comparative analyses. Geolocators will also be deployed at both sites to track their distributions and activity patterns during the non-breeding season.

The Project Lead is now pregnant and will be going on maternity leave at the end of November. We have submitted a change request to pause the project during this time (except for the fieldwork which the Co-I will undertake). This will delay the final outcomes, but as this project is not time-critical it will not impact the project in any other way.
