The award letter was issued by the Darwin Initiative at the end of July. As the Darwin Initiative are a new funder for NOC, due diligence delayed acceptance of the award until early September. Additional contractual arrangements with our partners (JNCC) and subcontractors (Wood Plc) have further delayed the start of the project. Despite this, significant progress has been made within the project. Important events have included:

- Kick-off meeting for all partners (20th August)
- Shortlisting, but not finalisation, of the 1) human activities and 2) agreed structure for the 'Pressures/ Activities matrix' for BVI (1.1 and 1.3)
- Initial literature search on cumulative impact assessment tools suitable for the BVI (3.1)
- Two lead-partner meetings to resolve specific issues within the project

The delay in receiving the award letter and the prolonged project setup timescale within NOC has delayed the real start of the project by between 2-3 months. This was further compounded by the difficulties of generating partner agreements for all within the project. However, these issues are now resolved and as initial setup delays, will not reoccur again within the project.

The project leader has just returned from a bout of fieldwork in the Caribbean for another project. The restrictions imposed by a state of emergency within Antigua (curfews etc.), a lack of accomodation, places to eat, hire cars and vessels available for work at sea made the fieldwork extremely challenging. Based on these experiences, the project lead will not be recommending in-country visits to partners within the next 3 months.
