**Aim:** The project aims to examine the potential benefits of undertaking a national ecosystem assessment on Anguilla.

In order to achieve this aim the following key questions will be answered.

- 1. What is the current state of knowledge of Anguilla's ecosystems?
- 2. What are the potential economic benefits from conducting a national ecosystem assessment on Anguilla?
- 3. How does the current administrative, policy and legislative context encompass Anguilla's ecosystems and does it allow for the development of a green economic strategy?

#### Proposed activities:

The following activities will be undertaken to address the overall aim.

- 1. To examine the administrative, policy and legislative context in which an ecosystem assessment for Anguilla would be set.
- 2. To evaluate the ways in which the Department of Environment's leadership of an ecosystem assessment would assist Anguilla in meeting its wider international policy commitments and the goals set by national policy.
- 3. To review the extent to which the current and planned research portfolio of the DOE and its partners has already, or is likely to, put in place all the elements of an ecosystem assessment.
- 4. To identify potential information sources, both nationally and internationally as well as potential partners, both within Anguilla itself and internationally.
- 5. To research and provide clear guidance of options for conducting a national ecosystem assessment, including benefits and costs. Department of Environment will liaise with the UK's Joint Nature Conservation Committee to secure access to UK advice on implementing a national NEA including advice from senior UK Government scientists involved in the UK NEA and advice from the WCMC who coordinated this project.

#### Background

Anguilla's ecosystems have traditionally provided an important source of income through export of products, and through exploitation of the island's unique biodiversity to promote tourism. At the same time, these ecosystems support the livelihoods of the population of Anguilla through the provision of multiple ecosystem services, including provision of fresh water, maintenance of soil fertility and a variety of food resources. Our marine parks - although not fully efficient- are proof that if managed effectively, ecosystems can provide significant support to the island's economy. However, research conducted by NBSAP and other agencies has confirmed that there is a need to increase the level of awareness on the importance and economic value of Anguilla's various ecosystems. These range from dry xeric land, forest and wetlands, to marine and coastal ecosystems.

As it stands, there has been no previous holistic ecological assessment of the economic benefits that can be derived from Anguilla's ecosystems. Instead, several articles of policy and legislation for the implementation of an Environmentally Sustainable Development Strategy have been established. These legislative documents outline and form the basis on which Anguilla's Sustainable Environmental Management and Development are guided, but are not as effective as they should be, owing to the incompletion of some key elements. Such key elements include the production of an ecological assessment report on the economic benefits that Anguilla's ecosystems might potentially provide, and how these could be exploited on a sustainable basis.

The resources sought by this proposal are pivotal, because the proposed project would initiate the development of a framework for an ecosystem assessment for Anguilla, enabling the development of a green economic strategy that will be built on the sustainable use of the island's ecosystem services. The assessment will permit Anguilla to utilise its ecosystem services in a sustainable manner, which in turn will enhance economic development and poverty alleviation. Likewise, this exercise will inform the

country's biodiversity conservation policy.

Location: The project will focus on the Anguillian archipelago.

Project duration: June 2012 to April 2013.

**Project Purpose**: To successfully determine the potential benefits of undertaking a national ecosystem assessment for Anguilla.

#### Project Outputs: Following the scoping exercise it is expected that:

- a. Guidelines and a strategy will be developed for conducting the ecosystem assessment
- b. A report highlighting the present and future ways the Ministry of Environment can assist Anguilla in meeting its wider international policy commitments, including the CBD, and the goals set by national policy.
- c. A comprehensive report on past and current research relevant to an ecosystem assessment to be conducted in Anguilla, and an indication of how both knowledge and expertise relating to the ecosystems of Anguilla might effectively be mobilised during a national assessment.
- d. A cost-benefit guidance analysis of options for conducting an ecosystem assessment to initiate the development or a green economic strategy. This will include lessons learned from conducting national ecosystem assessments in other countries, specifically the UK (see above).

#### Impact of the Project

The project will directly support the implementation of the Anguilla's Environmental Charter and help meet the UKOT's various environmental obligations including the CBD, RAMSAR, CMS and CITES. The Darwin project supports Anguilla's commitment in the Environmental Charter and the Organisation of Eastern Caribbean States- St. Georges Declaration through the following activities:

- ✓ Bringing together government departments, representatives of local industry and commerce, environment and heritage organisations, the Governor's office, individual environmental champions and other community representatives in a forum to formulate a detailed strategy for action
- ✓ Ensuring the protection and restoration of key habitats, species and landscape;
- ✓ Creating sensible and sustainable trade as well as establishing cooperation in science and technology.
- ✓ Creating a better quality of life for all citizens through job creation in the environment.
- ✓ Ensuring that sustainable economic opportunities are derived from effective ecosystem management.
- ✓ Further institutionalising the need for integrated development planning, where, ecosystem management, and all the other relevant issues are included.
- Ensuring that environmental considerations are integrated within social and economic planning processes, and promote sustainable patterns of production and consumption within the Territory.
- Reviewing the range, quality and availability of baseline data for natural resources and biodiversity.

This project supports the three main goals of the Convention on Biological Diversity, namely: a) conservation of biological diversity (or biodiversity); b) sustainable use of its components; and c) fair and

equitable sharing of benefits arising from genetic resources. It also supports UK and Anguilla's commitments to Ramsar and CMS as Anguilla's various ecosystems support several migratory species.

DOE expertise includes Natural Resources Management, Agro-biodiversity, Enthomology, Forestry, Plant Conservation, Environmental /Civil/ Coastal Engineering, Climate Change and Sustainability, and Marine Science. DOE has successfully implemented various projects such ACRAMAM, Enhancing Environmental Legislation, Biodiversity Strategy Project, CITES Enhancement in Anguilla, and the Soil Amelioration Project.

## UK Partner (JNCC) will provide:

- (i) advice on how to conduct a national ecosystem assessment, following best practice or lessons learned from experience in the UK, in terms both of the process and the methods used
- (ii) identification of potential data sources and areas of expertise within UK institutions, including both the academic and NGO communities
- (iii) identification of how a national ecosystem assessment can support the development of a green economy, incorporating sustainable use of ecosystem services, and how this can be achieved in practice; this might require reviewing relevant literature and case studies from other territories, plus elicitation of expert advice.

This will be achieved by short-term missions to UK by DOE staff to meet JNCC experts and WCMC (Cambridge) who coordinated the UK NEA and selective missions to Anguilla by UK personnel. Note: Costs incurred by JNCC staff travel will be met by JNCC and not drawn from any Darwin Challenge Fund award. JNCC will establish an internal group of key staff to support this project.

# 7. Justification of need for a Challenge Fund award. Please provide details of why alternative funding is not available from within your own organisation or from other sources. Will matched funding be provided? (max 250 words)

In spite of placing high importance on environmental conservation and management, the Government of Anguilla is currently constrained by a reduction in revenue, a consequence of the global economic crisis. Tourism and related activities constitute the major source of revenue but recently this has decreased significantly. The Anguillian Tourism niche is built on the basis of the pristine ecosystems and the biodiversity that they support. As such, the Anguilla government is experiencing a fiscal crisis and has had to implement rigid controls on expenditure. As a result, the Department of Environment has a significantly reduced budget and has to operate on scare resources. Hence, we lack relevant funds for conducting this exercise.

Although the government would like to allocate funds for environmental management, the limited revenue available to Anguilla Government has had to be directed to basic government activities. Anguilla Government and the UK Government have an obligation to fulfill their commitments to international conventions such as the CBD and Ramsar but in the current financial situation Anguilla is struggling to achieve these obligations.

The various ecosystems on Anguilla have important significance in terms of their biodiversity composition or the species they support. The Challenge Fund award would help support Anguilla Government fulfill its obligations to international conventions and the protection of important Anguillian habitats and species. The DOE will provide matched funding in the form of staff time, office space, office supplies, equipment and the use of the DOE's vehicle.
