April: All major targets were reached. These included recruiting two new Darwin Assistants and participation in the Madagascar workshop for the IUCN Global Mammal Assessment. We also organised a three-day regional workshop on integrating bat conservation into primary school teaching. GIS and English Language courses were attended by project staff. Preparatory meetings for creation of the new NGO.

May: Four months ahead of schedule we registered a new conservation organisation called Madagasikara Voakajy with the Malagasy government. Our Board of Trustees consists of five leading Malagasy conservationists. Radio tracking and acoustic surveys of microchiropterans in littoral forests began. Three new Darwin Trainees recruited.

June/July: Field research on fruit bat pollination of endangered baobab trees. One Darwin Assistant attended a Tropical Biological Association field course in Uganda.

August: Field research on habitat preferences in small fruit bats. Second phase of radio tracking and acoustic survey project in littoral forest. One Darwin Assistant attended Advanced Acoustic Survey Workshop in Pennsylvania, US.

September:Professor Racey visits for one month. First board meeting of Madagasikara Voakajy. Fruit bat conservation days held in two primary schools. Course in Payroll/Pension attended by our Malagasy project administrator.
