#### 0. Project management arrangements in place and operational

- Memorandum of Collaboration signed by project partners in August 2009
- Project co-ordinator recruited and started on Montserrat at beginning of September 2009
- FERA and RSPB visited in July, FERA visited again in September
- Regular teleconferences between partners to discuss project progress (15<sup>th</sup> April, 27<sup>th</sup> May, 1<sup>st</sup> July, 29<sup>th</sup> September, 30<sup>th</sup> October 2009)
- 30 participants attended stakeholder workshop on Montserrat (22<sup>nd</sup> July 2009) to agree project workplan
- 1<sup>st</sup> project steering committee meeting took place on Montserrat attended by all project partners (30<sup>th</sup> July 2009)

#### 1. Knowledge of existing feral livestock in and around the Centre Hills is increased

- 8 Boar Operated Systems (BOS) built on Montserrat
- 30 remote monitoring cameras purchased, 23 deployed into the field (19<sup>th</sup> July 17<sup>th</sup> September)
   BOS monitoring tested on Montserrat (19<sup>th</sup> 31<sup>st</sup> July) in 3 areas, 4 more deployed 2<sup>nd</sup>-11<sup>th</sup>
- BOS monitoring tested on Montserrat  $(19^{th} 31^{st} \text{ July})$  in 3 areas, 4 more deployed  $2^{nd}$ -11 September
- Mapping of agricultural and livestock plots discussed with DOA. Completed for Duck Pond
- Survey of public attitudes to pig consumption under preparation with statistics department Livestock data from DOA collated on local production of meats between 2001-2008 and the number of loose livestock impounded 2007 onwards. Further to this data on imported meats, a livestock owner survey and reported damages to crops will be added
- Camera trap pictures (19<sup>th</sup> July 25<sup>th</sup> September): 397 of pigs, 4 of goats, 497of cattle, 311 other animals
- Montserrat Water Authority are recording sign of feral livestock activity around springs
- Proposal for livestock backyard project in development for submission to OTEP
- Trials on seed dispersal by feral pigs initiated

  - Training materials completed for BOS monitoring, data collection, cameras and pig identification

# 2. Give details of any notable problems or unexpected developments that the project has encountered over the last 6 months. Explain what impact these could have on the project and whether the changes will affect the budget and timetable of project activities.

Most activities are progressing according to the project schedule. Although not planned in the original project application, with RSPB support, the DOE have contracted a project co-ordinator to manage the project on Montserrat full-time until September 2010.

This is the first time the Boar Operated System (BOS) has been used in the tropics and monitoring has experienced problems with low pig visitation. In response, we have delayed intensive BOS monitoring and weekly monitoring will continue into the beginning of November. The bait has been changed and we will begin to use both natural and commercial attractants to overcome this problem. The activity of the Soufriere volcano has increased in recent days which will limit our access to the exclusion zone and may hinder BOS monitoring and partly camera monitoring. 5 cameras have failed but this has not impacted on data due to contingency cameras. We are seeking to have these cameras repaired/replaced at no cost.

The project leader has moved to a new position at the RSPB so will handover responsibility for the project to James Millett (UKOT Caribbean International Officer) at the beginning of December 2009 on Montserrat.

### Have any of these issues been discussed with the Darwin Secretariat and if so, have changes been made to the original agreement?

We have not yet informed the Darwin Secretariat of the project management changes at RSPB. As there will be no changes to the budget and project timetable, we hope this is acceptable.
