Review the initial implementation of MOMs at community level as basis for developing annual work plan for the MOMS team					The (Community Extension Team) CET reviewed the challenges in implementing MOMS at community level and found that there is a need to have closer mentoring of the community MOMS team especially the members who are not regularly providing reports. The assigned CET staff for each village also need to be familiar with the forms so they will be more effective in coaching the MOMS teams. A refresher course for CET was conducted for this. They also reviewed the existing MOMS books and improved some to make them more user- friendly.
MOMS champions identified, trained and supported					The CET staff assigned as overall coordinator of the MOMS at community level resigned. The staff who took over the assignment is just getting familiarised with the work.
Train MOMS team on monitoring natural resource use including NTFPs					Part of the MOMS refresher course for the CET is the orientation on how to use the newly developed NTFP MOMS form (see attached sample form). Next step is to train the MOMS at community how to use the newly developed forms.

1.6 Update information in all the 3D model maps produced in previous project					Four 3D models maps in four communes have been updated to include the current changes in the land uses (i.e. new rubber plantations and expansion farms); two communes recently completed their commune land use plan but the planning was done only by the commune council members ¹ . Since most of the villagers are now aware of the new land use plan, the 3D model updating workshop was used to inform and get feedback from the communities of the proposed land uses in their villages.

The approval of documents, such as benefit sharing mechanism and revision of ToR of WEMB, by the FA (Provincial Government) takes a very long time. One of the reasons is that the National FA does not have the guidelines yet for tourism in the protected area managed by FA. This might cause a delay in the timetable of the operation of the WEMB and a smooth operation of the distribution of ecotourism revenues from the homestay and activities.
